

## **OFFICIAL CONTEST RULES**

### **“Fuel for the City” Contest**

#### **102.9 The Whale – WDRC-FM (Full Power Radio)**

These Official Contest Rules (“Rules”) govern the “Fuel for the City” contest (“Contest”) conducted by Full Power Radio, licensee of WDRC-FM (102.9 The Whale) (“Station” or “Sponsor”). Participation in the Contest constitutes Entrant’s full and unconditional agreement to these Rules and to the decisions of the Station, which are final and binding in all respects.

#### **1. ELIGIBILITY**

- Open to legal U.S. residents of Connecticut, age 18 years or older at time of entry.
- Employees, officers, directors, agents, and representatives of Sponsor, its affiliates, subsidiaries, third-party sponsors, and their immediate family members or household members are not eligible.
- Void where prohibited by law.

#### **2. NO PURCHASE NECESSARY**

No purchase or payment of any kind is necessary to enter or win. A purchase does not increase the chances of winning.

#### **3. CONTEST PERIOD**

- Contest begins April 27, 2026 and ends June 5, 2026.
- Conducted Monday through Friday only, excluding Station-observed holidays.
- Sponsor reserves the right to modify, suspend, or terminate the Contest at any time, for any reason, in its sole discretion.

#### **4. HOW TO ENTER**

- Enter online at [www.1029thewhale.com](http://www.1029thewhale.com) by completing the official entry form.

#### **Entry Conditions:**

- Limit one (1) entry per person/email address.
- Duplicate, incomplete, or fraudulent entries will be disqualified.
- Automated entries or entries generated by script, macro, or other mechanical means are prohibited.
- All entries become the property of the Sponsor and will not be returned.

## 5. CONTEST PLAY / HOW TO WIN

Contest plays will occur weekdays at approximately:

- 9:20 AM ET
- 11:20 AM ET
- 1:20 PM ET
- 3:20 PM ET

During each Contest Play:

- One (1) Entrant's name and hometown will be announced on-air.
- The selected Entrant must call 860-242-1029 within ten (10) minutes of the announcement.

## IMPORTANT CONDITIONS

- The Station is not responsible for missed announcements due to signal issues, streaming delays, or listener error.
- Online streaming may be delayed and should not be relied upon for participation.
- Names will be announced one (1) time only.
- The Station's official clock shall control all timing.
- Telephone system limitations, including busy signals or dropped calls, do not extend the call-in period.

## IDENTITY VERIFICATION

- Entrant must verify all registration information.
- Only the selected Entrant may claim the prize.
- Failure to verify identity or comply with Rules will result in disqualification.

## 6. PRIZES

- Each verified winner will receive one hundred dollars (\$100) via Station-issued check.
- Up to four (4) prizes may be awarded per Contest Day.

Prize Conditions:

- Non-transferable and non-exchangeable.
- No substitution except at Sponsor's discretion.
- Payment issued within thirty (30) business days upon completion of required documentation.

## 7. TAXES

All federal, state, and local taxes are the sole responsibility of the winner. Applicable IRS reporting requirements will apply.

## 8. ODDS OF WINNING

Odds of winning depend on the number of eligible entries received.

## 9. THIRD-PARTY SPONSOR PROTECTIONS

Third-party sponsors, if any, are not responsible for Contest administration or prize fulfillment unless otherwise stated. Entrants agree to release and hold harmless all such sponsors from any liability arising from participation in the Contest or use of any prize.

## 10. FRAUD / TAMPERING

Sponsor reserves the right to disqualify any Entrant who tampers with the entry process, violates these Rules, or engages in fraudulent or disruptive behavior.

This Contest may be promoted via social media platforms. It is not sponsored, endorsed, or administered by any social media platform. Entrants release such platforms from any liability.

By participating, Entrants grant Sponsor the right to use their name, likeness, voice, and city/state for promotional purposes without additional compensation, except where prohibited by law.

## 13. LIMITATION OF LIABILITY

Entrants agree to release and hold harmless Sponsor, its affiliates, and all third-party partners from any liability arising from participation in the Contest or acceptance/use of any prize.

## 14. INDEMNIFICATION

Entrants agree to indemnify and hold harmless Sponsor and all third-party sponsors from any claims, damages, or liabilities arising from participation in the Contest or breach of these Rules.

## 15. FORCE MAJEURE

Sponsor shall not be liable for failure to conduct the Contest due to events beyond its control, including but not limited to weather, technical failures, or government action.

## 16. GOVERNING LAW

This Contest is governed by the laws of the State of Connecticut. All disputes shall be resolved exclusively in Connecticut courts.
