**CRIMINAL COMPLAINT**

I, the undersigned complainant being duly sworn, state the following is true and correct to the best of my knowledge and belief:

**COUNT ONE**  
***Escape from Confinement***

On or about December 5, 2022, in the Western District of Missouri, the defendants, **TREVOR SCOTT SPARKS** and **SERGIO PEREZ MARTINEZ**, did knowingly and intentionally escape from the custody of a facility in which they were confined by a District Court Judge by virtue of process under the laws of the United States for a felony offense, all in violation of Title 18, United States Code, Section 751(a).

**COUNT TWO**  
***Aid or Assist Escape from Confinement***

On or about between December 5, 2022 and December 6, 2022 in the Western District of Missouri, the defendants **TREVOR SCOTT SPARKS**, **SERGIO PEREZ MARTINEZ**, and **STEVEN LYDELL WILLIAMS, SR. (a/k/a "Pops")** did knowingly and intentionally instigate, aid, and assist the escape of Trevor Scott Sparks and Sergio Perez Martinez, persons arrested upon a warrant under the laws of the United States for

a felony offense and committed to the custody of a facility under the direction of the Attorney General, all in violation of Title 18, United States Code, Section 752(a).

I further state that I am a Special Agent with the Federal Bureau of Investigation, and that this complaint is based on the facts contained in the attached affidavit, made a part hereof as if set out herein word for word.
