

ORGANIZATIONAL FLOW CHART





SPECIALIZED TRAFFIC ENFORCEMENT



Traffic Enforcement Summary – August 2025

The Henry County Sheriff’s Office conducted specialized traffic enforcement efforts targeting hazardous moving violations, particularly during high-traffic periods. These efforts focused on state-maintained highways that see heavy use by commuters, school staff, and students, including MO-Highway 7, MO-Highway 52, MO-Highway 18, MO-Highway 2, and MO-Highway 23.

These efforts resulted in 7 citations (including 6 for speeding and 1 for driving while suspended/revoked), along with 66 warnings issued for various violations ranging from speeding to stop sign offenses. Deputies also made 4 arrests, including one for driving while suspended and three on misdemeanor warrants. A K9 sniff was conducted during enforcement activity, further supporting proactive highway safety efforts.

Looking at the broader picture, our year-to-date totals through the first and second quarters (January–June) included 533 stops, 324 hours of enforcement, 36 citations, 547 warnings, and 7 arrests. Combined with July and August’s operations, we are maintaining a steady, visible presence across Henry County’s busiest roadways.

This initiative was supported by a Missouri Department of Transportation grant, reinforcing our commitment to reducing traffic-related injuries and fatalities. Moving forward, the Henry County Sheriff’s Office will continue strategic enforcement efforts throughout 2025, ensuring that our roads remain safe for all residents.


CORRECTIONS

The Detention Center’s average daily population (ADP) in August was 113 inmates, continuing the upward trend we’ve seen this year as enforcement and prosecution remain steady. Of this total, 6% were Missouri Department of Mental Health holds and another 3% were court-ordered evaluations. In all, the jail processed 111 bookings and 116 releases during the month.


Staffing adjustments continue as our detention officers balance their duties with the demands of the part-time academy. While coverage has been a challenge, we are proud to see our cadets smiling as they pass exams and press forward in their training.

Training remained a priority in August, with five officers completing more than 72 hours of instruction. This included two staff members earning their Crisis Intervention Training (CIT) certificates, along with expanded training in jail operations and medical support. These investments strengthen both our staff and the services we provide to the community.

COURT SECURITY

The Henry County Courthouse, a historic landmark in Clinton, Missouri, serves as the central hub for the county's judicial proceedings. Within its walls, the courthouse accommodates both the Associate Circuit Court and the Circuit Court, each handling a distinct array of cases to ensure comprehensive justice for the community.

To maintain a secure and orderly environment, the Henry County Sheriff's Office has appointed three full-time bailiffs. These dedicated officers are responsible for overseeing security checkpoints, managing courtroom activities, and ensuring the safety of judges, staff, and the numerous visitors who pass through the courthouse daily. Their presence is especially crucial given the high volume of jury trials and the significant public engagement within our beautiful courthouse.

The courthouse itself is a testament to architectural elegance, featuring multiple levels dedicated to various judicial functions. There are four levels in use, with a third courtroom in the basement to accommodate the growing demands of our judicial system.

The collaborative efforts of our bailiffs, court staff, and the Sheriff's Office exemplify our dedication to upholding the integrity of the judicial process while ensuring the safety and well-being of all who enter the courthouse. As we continue to experience an increase in jury trials and public participation, these measures are vital in maintaining the esteemed reputation of our county's judicial system.
