





Shall the Board of Education of the Fairview R-XI School District of Howell County, Missouri, borrow money in the amount of Five Million Dollars (\$5,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new gymnasium; to complete the expansion of several classrooms; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.5700 per one hundred dollars of assessed valuation?
