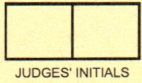

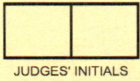

**Special School Bond Election
Proposition 2**

Shall the Board of Education of the Mansfield R-IV School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Six Million Dollars (\$6,000,000) for the purpose of providing funds for the site development, construction, equipping and furnishing of a storm resistant performing arts building; to construct security entrances; to the extent funds are available, complete other renovation and repair improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.0700 per one hundred dollars of assessed valuation of real and personal property.

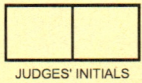
