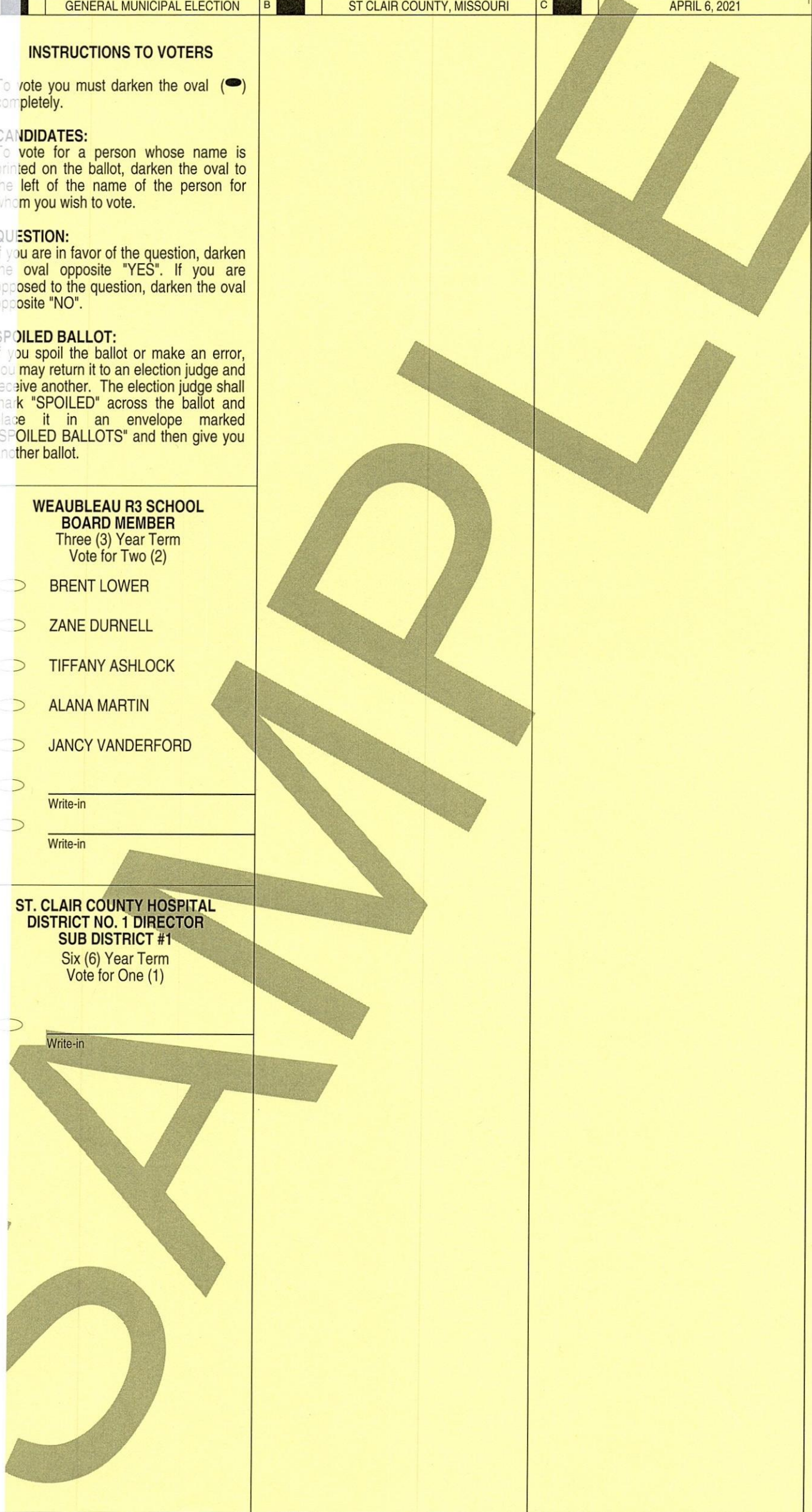

Shall the board of Education of the Appleton City R-II School District, Missouri, be authorized to increase the operating tax levy by \$0.5000 per one hundred dollars of assessed valuation through Tax Year 2040 in order to provide funds for the repair and replacement of roofs; upgrades to heating, ventilation, and air conditioning (HVAC) systems; improving and upgrading handicap accessibility Districtwide; remodeling of the elementary school; improving and expanding Ag facilities in the District; completion of other renovations and repair improvements to existing facilities; and to meet the additional operating needs of the District?

(If this proposition is approved, the adjusted operating levy of the District is estimated to increase by \$0.5000 from \$3.7909, currently, to \$4.2909 per one hundred dollars of assessed valuation for Tax Year 2021 and can be applied to the assessed valuation for each year thereafter through Tax Year 2040.)
