The ballot for the election shall be substantially in the following form.

INSTRUCTIONS TO VOTERS:

To vote, use only the pen provided to completely fill in the oval to the left of your choice like this: 

If you make a mistake, ask the poll worker for a new ballot.

CANDIDATES: To vote for a person, darken the oval to the left of the name of the person for whom you wish to vote.

WRITE-IN: To vote for a person whose name is not printed on the ballot, write his or her name in the blank space provided for such purposes and darken the oval to the left of the space.

PROPOSITIONS or QUESTIONS: If you are in favor of the proposition or question, darken the oval next to the word "YES". If you are opposed to the proposition or question, darken the oval next to the word "NO".

Further Notice is given that, where a regular polling place has limited accessibility, a disabled or elderly voter may be provided an alternate means of casting his or her ballot. Such means may include reassignment to an accessible polling place, curbside voting, assisted voting
