



## RADLEY AUTOMOTIVE GROUP RULES AND REGULATIONS FOR COMMUNITY CASH 2022

**ELIGIBILITY: NO PURCHASE NECESSARY.** Open only to legal residents of Virginia, Maryland and District of Columbia who are eighteen (18) years or older on date of entry. Void where prohibited by law, rule, regulation or ordinance. Employees and directors of Radley Automotive, Centennial Broadcasting II, LLC, d.b.a. WBQB (B101.5), their affiliated companies, participating Sponsors, information providers, content providers, subsidiaries, advertisers, advertising agencies, promotional and marketing agencies (and their immediate family members and those living in the same households) are ineligible.
