

## WBQB OFFICIAL RULES: BACKSTREET BOYS VEGAS FLYAWAY

**ELIGIBILITY: NO PURCHASE NECESSARY**. Contest is only open to residents of the United States, who are twenty-one (21) years or older on date of entry and abide by these Official Rules. This Contest is void where prohibited by law, rule, regulation or ordinance. Employees and directors of Centennial Broadcasting II, LLC, d.b.a. WBQB (B101.5), their affiliated companies, participating Sponsors, information providers, content providers, subsidiaries, advertisers, advertising agencies, promotional and marketing agencies (and their immediate family members and those living in the same households) are ineligible. By participating, you agree to these Official Rules and to the decisions of the judges which are final and binding in all respects. Centennial Broadcasting II, LLC, d.b.a. WBQB assumes no responsibility whatsoever for any telephone charges, whether long distance, local toll, wireless or data use charges incurred by a contestant participating in this promotion.

**SPONSOR:** Centennial Broadcasting II, LLC, d.b.a. WBQB and B101.5 ("B101.5" or "Sponsor") is the sole sponsor of The Backstreet Boys Vegas Flyaway Contest ("Contest") that is responsible for awarding designated prize(s) to the verified winner(s) of the contest. Any advertisers of B101.5 identified as participating advertisers may have contributed to the available prizes in this Contest, but B101.5 is solely responsible for operating the Contest.

**WHEN AND HOW TO PLAY**: This Contest will be conducted weekdays (Monday through Friday only) starting Monday 6/16/25 and continue until 6/23/25 ("Contest Period"). Sponsor may end the contest period early.

During the Contest Period, each instance where B101.5 airs two Backstreet Boys songs backto-back (ie. 2-in-a-row), listeners must be caller number ten (10) as soon as the second Backstreet Boys song airs to "qualify" for the opportunity to be included in a random drawing for a chance to win the "Grand Prize" as defined in the Prize(s) section below. The "Grand Prize" will be awarded by random on-air drawing from all eligible qualifiers on Monday, June 23rd, 2025.

"Backstreet Boys songs" are defined as any song where Backstreet Boys are listed as the main or featured artist.

Sponsor's time keeping device is the official time keeping device for purposes of this Contest, including any tie-breaker decisions. Sponsor will appoint a panel of qualified judges to judge who is the applicable 10<sup>th</sup> caller to have their call "get through" to B101.5 following airplay of the second Backstreet Boys song on B101.5 on a weekday during the Contest Period.

Only one (1) eligible "Qualifier" per household is allowed during the Contest Period. Qualifiers are not classified as "winners" and therefore not bound by the 30 or six-month restriction

periods as defined in "Restrictions" below for any contest, but MUST meet all "Restrictions" requirements on the date the Grand Prize is drawn.

B101.5 reserves the right to record all incoming phone calls and play them back on the air.

All persons meeting the criteria to "win" a prize are only potential winners until their eligibility to be a winner is confirmed by Sponsor, which may not be possible in "real-time" or "on-air."

## PRIZE(S): One (1) "Grand Prize" will be awarded to include:

- Two (2) entry tickets to The Sphere in Las Vegas for the July 11<sup>th</sup> "Backstreet Boys Into the Millennium" residency show.
- Two (2) nights hotel accommodation in Las Vegas.
- Two (2) round trip coach airfare tickets between a Washington, DC, or Richmond airport to a Las Vegas area airport.
- 1. Sphere Tickets are designated for the July 11<sup>th</sup> show, but dates are subject to change at the Sponsor's discretion.
- 2. Hotel accommodations are for one (1) room to be available for two (2) consecutive nights scheduled at the Sponsor's discretion. Winner must be 21 or over.
- 3. Airfare will be arranged by the Sponsor and will include 2 coach-class seats on an airline of the Sponsor's choice. While all attempts will be made to accommodate the departure airport of choice for the winner, this cannot be guaranteed. All attempts will be made to depart from either Richmond or Washington, DC, area airports.

Prize value is approximately \$1500.00 All other expenses incurred are the responsibility of the winner.

**RESTRICTIONS: Limit one (1) winner per household in this Contest.** Pursuant to the B101.5 General/Generic Contest Rules, listeners may only participate in and/or win a contest once every thirty (30) days. Only one (1) winner per household will be awarded a prize in any (30) day span. Winner of any prize valued at \$500 or more must wait six (6) months before participating in any other contest.

Sponsor reserves the right to suspend, discontinue, change, extend, halt and/or restart the Contest at any time if the Contest cannot be administered as planned or due to circumstances beyond Sponsor's control. Any such changes will be reflected in an update to these Official Rules. Entrants should not use bots or non-human intervention (e.g., computerized entry software) to enter; entrants who do so risk disqualification.

**UNCLAIMED PRIZES NEED NOT BE AWARDED. Prize(s) will only be awarded upon winner verification of eligibility to claim a prize under these Official Rules**. All decisions of judges in this Contest are final. Taxes, fees or other charges in connection with claiming or using a prize, if any, are the sole responsibility of winner(s).
