


## "I Voted" Sticker Design Challenge Drawing Template


This page is provided as an optional drawing template to help artists design their sticker.

## **“I Voted” Sticker Design Challenge Official Guidelines**

### **Who May Participate**

The “I Voted” Sticker Design Challenge is open to community members in the following categories:

**Future Voter: Under 13 years of age**

**Youth: Ages 13-18**

Submissions for participants under 18 years of age must include the parent/guardian consent form.

### **Design Requirements**

All designs must:

- Include the words “I Voted”
- Be nonpartisan (no candidates, parties, political advocacy, etc.)
- Be original artwork created by the participant
- Be appropriate for all ages
- Be suitable for printing as a 3” circular sticker

Artwork may be hand-drawn or digitally created.

AI-generated imagery and copyrighted characters or logos are not permitted.

### **How to Enter**

Designs may be submitted electronically or in person between January 12 - February 13<sup>th</sup>.

Participants may submit up to two designs.

### **Selection of Designs**

A review panel will select the top three designs in each category, followed by a short community voting period via Flash Vote to determine the final winners.

The City reserves the right to make minor adjustments to selected designs to meet printing requirements.

### **Use of Artwork**

By submitting a design, participants (and parents/guardians, if applicable) grant the City of Valdez permission to reproduce and display the artwork in connection with this election and related civic engagement efforts. Submission does not guarantee selection or use.

### **No Compensation**


Participation is voluntary. No monetary compensation will be provided.

### **Liability**

The City of Valdez is not responsible for lost or damaged submissions, and is not liable for claims arising from participation, except in cases of gross negligence or willful misconduct.

1. I am the parent or legal guardian of the minor named above, and I give permission for my child to participate in the City of Valdez "I Voted" Sticker Design Challenge.

4. I understand participation in this program is voluntary and no monetary compensation will be provided.
5. I understand the City of Valdez may identify my child by first name and age group only (e.g., "Youth Category Winner") unless additional permission is requested and granted.
6. I release the City of Valdez and its employees from any claims arising from my child's participation in this program, except in cases of gross negligence or willful misconduct.
7. I understand this consent applies only to this challenge and related civic uses. The City is not obligated to use my child's artwork.
