# WIYY-FM (98ROCK) Scott & Kirk's Cinco de Mayo Bus Tour Sweepstakes Official Rules

## 1. **GENERAL**:

No purchase necessary. Making a purchase will not increase your chances of winning. Void where prohibited or restricted by law. All federal, state, and local regulations apply.

## 2. ELIGIBILITY:

Scott & Kirk's Cinco de Mayo Sweepstakes ("Sweepstakes") is offered only to legal U.S. residents 21 years old or older at the time of entry. One winner per household. One winner per family. Prizes are non-transferable. Sweepstakes is offered only to residents who reside within the **Baltimore** Designated Market Area ("DMA") as determined by Nielsen Media Research Services. Winners of a contest or sweepstakes hosted or sponsored by **98ROCK** or its affiliates within the past fifteen (15) days (from the first day of the Sweepstakes Period of this Sweepstakes) are not eligible. Employees of 98ROCK and members of their immediate families, Hearst Stations Inc. ## 3. HOW TO ENTER:

The Sweepstakes will begin at 5:00 a.m. EST on April 11, 2022 and end at 7:00 p.m. EST on April 15, 2022 ("Sweepstakes Period"). All times in these rules refer to Eastern Standard Time.

On each weekday of the Sweepstakes Period, April 11, 2022 through June 17, 2022, between two (2) "Cues to Call" or "Cues to Text" will be announced on 98ROCK during one or more of the following shows, within the referenced time frames: Justin, Scott and Spiegel (including breaks) between 5:00 a.m. and 10:00 a.m.; Kirk + Marianne's The Boom Boom Room (including breaks) between 2:00 p.m. and 7:00 p.m. (the "Programming"), for a total of ten (10) "cues". Listeners must listen for the "Cue to Call or Text," because knowledge of the "Cue" is necessary in order to submit an eligible entry (and, in some cases, a keyword).
