**98ROCK Orioles Grand Slam Sweepstakes**  
**Official Rules**

**1. GENERAL:**

No purchase necessary. Making a purchase will not increase your chances of winning. Void where prohibited or restricted by law. All federal, state, and local regulations apply.

**2. ELIGIBILITY:**

**98ROCK Orioles Grand Slam Sweepstakes** (“Sweepstakes”) is offered only to legal U.S. residents 18 years old or older at the time of entry. One winner per household. One winner per family. Prizes are non-transferable. Sweepstakes is offered only to residents who reside within the **Baltimore** Designated Market Area (“DMA”) as determined by Nielsen Media Research Services. Winners of a contest or sweepstakes hosted or sponsored by **98ROCK** or its affiliates within the past fifteen (15) days (from the first day of the Sweepstakes Period of this Sweepstakes) are not eligible. Employees of **98ROCK** and members of their immediate families, Hearst Stations Inc. (Together, “Sponsor”) Hearst Corporation, Woobox, Zipwhip, and each of their affiliates, representatives, and agents, and their directors and employees (collectively, “Sweepstakes Entities”), and the members of the same households of such individuals are not eligible. The term “immediate families” includes spouses, grandparents, parents, siblings, children and grandchildren. No groups, clubs, or organizations may participate in this Sweepstakes or reproduce or distribute any portion of these Official Rules to their members. Proof of age, identity, and eligibility must be furnished to Sponsor upon request. All entry form information must be complete and accurate. Sponsor will not award a prize to anyone not meeting eligibility requirements at the time of entry. By entering, you agree to comply with all applicable law and these Official Rules, and you agree to abide by all decisions of the Sponsor. Sponsor reserves the right to disqualify any entrant if these Official Rules are not followed. A text messaging two-way capable handset and digital service is necessary for one (1) of the ways to enter, as well as knowledge of the day’s keyword.

**3. HOW TO ENTER:**

The Sweepstakes will begin at **7:00 a.m. EST on March 31, 2023** and end at **11:59 p.m. EST on June 8, 2023** (“Sweepstakes Period”). All times in these rules refer to **Eastern Daylight Time**.

On each weekday of the Sweepstakes Period, March 31, 2023 through June 8, 2023, between one (1) and five (5) “Cues to Call” or “Cues to Text” will be announced on 98ROCK during one or more of the following shows, within the referenced time frames: Justin, Scott and Spiegel (including breaks) between 7:00 a.m. and 10:00 a.m.; Middays with Amelia (including breaks) between 10:00 a.m. and 2:00 p.m.; Kirk + Marianne’s The Boom Boom Room (including breaks) between 2:00 p.m. and 7:00 p.m. (the “Programming”), for a total of fifteen (15) “cues” per week. In addition, a schedule of additional times for entry will be given at 7:30 am each weekday morning. Please note: no cues to call or text will occur during the airing of Orioles games.

Listeners must listen for the “Cue to Call or Text,” because knowledge of the “Cue” is necessary in order to submit an eligible entry (and, in some cases, a keyword). All entries must be received during each respective Entry Day, which starts every weekday during the Sweepstakes Period at 7:00 a.m. and ends that evening at 11:59 p.m. (each an “Entry Day”). Additionally, each “cue” will have its own deadline to enter as stated by the on-air personality at the time of each chance to win.

There are two ways to enter (however, each given cue will specify only one method):

On-Air Call to Win: Listen to 98Rock during the Sweepstakes Period for the cue to call. Call (410) 338-1098 and either answer the Question asked by the on-air personality or be the “X” number caller, as decided by the on-air personality, to become a Finalist.

Text to Win: Listen to 98ROCK during the Sweepstakes Period for the Text to Win Keyword. Participants may send a text message to (410) 338-1098 with the Keyword in the body of the message. All entrants entering via the text message entry method must have a text messaging two-way capable handset and digital service in order to enter the Sweepstakes. Entrants will be sent a text message to confirm entry into the Sweepstakes. Entrants entering by text will be charged standard text messaging rates for text messages sent and received from their handset according to the terms and conditions in their wireless calling plan. Standard text and data rates may apply. Text messaging and wireless service are not available in all areas. Limit one entry per person per day using this Entry Method.

Entries become property of Sponsor and will not be returned. Incomplete entries are void. Sponsor is not responsible for entries that are lost, late, misdirected, incomplete, incomprehensible, illegible, damaged, undeliverable or delayed. Photocopied and mechanically generated entries are void. Entries generated by any automated means are void. Electronic entries will be deemed to have been submitted by the authorized account holder of the e-mail address at the time of the entry. The authorized account holder is the person to whom the applicable internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address. Online entrants must have valid e-mail address and it is entrant’s responsibility to update Sponsor of any change in e-mail address.

#### **4. HOW TO WIN:**

Following each “Cue to to Call or Text”, Sponsor will randomly select one (1) entrant from all entries received by that day’s “Cue” deadline and, if eligible, that entrant will be the Daily Prize Winner. Alternatively, in the event the Cue involves being the “X”-numbered caller, or the first to respond with the correct keyword, one (1) entrant will be chosen who fulfills the given requirement. In addition, one (1) Weekly Grand Prize Winner will be chosen from all fifteen (15) Daily Prize Winners during each given week, Monday through Friday. Limit a maximum of one (1) Daily Prize and, if applicable, one (1) Weekly Grand Prize per person during the Sweepstakes Period.

Potential winners will be notified by phone on the day of each drawing. Winner must respond to such notification, by answering the phone call made by the on-air personality

or the Winner will be subject to disqualification, in which case the Prize will be forfeited, and an alternate Winner will be randomly selected from among the remaining eligible entries, time permitting. Winners may be required to sign and return appropriate forms and/or documentation, including an Affidavit of Eligibility, a Liability Release and/or where legally permissible a Publicity Release within **seven (7)** days following the date of first attempted notification. Winner hereby further agrees that it will sign any documents necessary to transfer copyright of the entry to Sponsor within **seven (7)** days following the date of first attempted notification. Failure to sign and return such forms within the requisite timeframe could result in disqualification.

Sponsor is not responsible for incomplete, incomprehensible, illegible, or out-of-service contact information. If Sponsor is unable, after making a reasonable effort, to contact a selected potential winner, that potential winner will be disqualified, and a new potential winner will be selected from remaining entries until all qualified Winners are chosen.

## **5. PUBLICITY RELEASE:**

Except where prohibited, entry in the Sweepstakes constitutes each entrant's consent to use, publish, reproduce and for all purposes, including publicity, promotion and advertising, in any media (including without limitation, the Internet, television, radio, or offline promotions), each Winner's name, city, photograph, likeness, biographical material, voice, image, each in perpetuity without further compensation, credit or right of review or approval.

## **6. PRIZES:**

One Hundred fifty (150) Daily Prize Winners will each receive:

- Four Tickets (4) Tickets to a Baltimore Orioles Home Game at Orioles Park at Camden Yards of your choice during the 2023 Season (based on availability at time of booking and with some restrictions).  
Approximate Retail Value ("ARV") of each Daily Prize: \$150

Ten (10) Grand Prize Winners will each receive:

- \$1,000 Cash Prize  
ARV of each Grand Prize: \$1,000.00

ARV of all prizes awarded: \$32,500

All charges, fees, and costs not specifically included in the prize descriptions above, including but not limited to personal incidental items, transportation, taxes, souvenirs, gratuities, and licenses, are the responsibility of the respective Prize Winners.
