**1. GENERAL:**

No purchase necessary. Making a purchase will not increase your chances of winning. Void where prohibited or restricted by law. All federal, state, and local regulations apply.

**2. ELIGIBILITY:**

Boardwalk Rock Listen-To-Win Weekend Sweepstakes ("Sweepstakes") is offered only to legal U.S. residents 18 years old or older at the time of entry. One winner per household. One winner per family. Prizes are non-transferable. Sweepstakes is offered to Maryland, Delaware, Virginia and Washington DC residents as well as the following counties in Pennsylvania: York, Harrisburg and Lancaster. Winners of a contest or sweepstakes hosted or sponsored by 98 Rock / WIYY or its affiliates within the past calendar year, as of the start date of this Sweepstakes, are not eligible. A Cue to Call will be announced to start each Entry Period.

**TO ENTER:** After the Cue to Call is announced, participants may call 410-338-1098 for a chance to win. The on-air personality will state in each respective Cue to Call which numbered caller will be the Winner.
