- 1) The matches will begin play at 5:30 PM.
- 2) Matches will be best 2 of 3 to 25 pts. If a 3rd game is needed it will be to 15 pts.
- 3) Referees will flip a coin for home team and for first serve.
- 4) Warm-up balls and game balls will be provided by the host school.
- 5) Warm-up times before the first matches of the evening will be (5-6-6). The warm-up period for subsequent matches will be 6 minutes (3-Visitors Net; 3-Home Net)
- 6) Warm-up periods will start as soon as the previous match is done, and the referees can conduct the coin flips for the next match.
- 7) The host school's score will always be on the home team part of the scoreboard even if they lose the flip and are the visiting team. This will help eliminate fan confusion.
- 8) Each team will required to supply a scorebook keeper and a line judge for the matches that you are scheduled to play. You may also bring a libero tracker if you wish. All these personnel will be admitted for free. If there is no libero tracker, the visiting team's scorebook person is responsible for libero tracking, and the home team's scorebook person will keep the official scorebook.
- 9) Local activity passes are not accepted. Twin Lakes Conference passes, administrator passes, and media passes will be accepted.
- 10) Admission prices are \$5.00/adult and \$3.00/student.
