Prize(s) and Value(s):

Qualifying Prize: One (1) \$25 Disney gift card. Total qualifying prize value is \$25.00.

Grand Prize: Up to four (4) round trip coach airfares for the Group between the major United States gateway airport closest to winner's residence ("Departure Airport") and a Southern California airport ("Arrival Airport") as chosen by Disney (with possible layovers); provided, however, if the winner resides within two hundred and fifty (250) miles of the Premises, airfare will not be provided (airports, airline carriers and flights to be selected by Disney in its sole and absolute discretion). How to Enter

Listen to STAR 101.5 FM for the keyword from Monday, February 5th, 2024 at 8:00 a.m. to Friday, February 16th, 2024 at 4:00 p.m. There will be a total of forty (40) keywords announced. Then, to enter, text the Keyword to the Texting Code. Standard text messaging rates apply to all text message entries

sent. By entering, entrants consent to and will receive text messages relating to this contest from an automated system. Consent is not required to buy goods and services. No mechanically reproduced or completed entries will be accepted.

How to Qualify and Win

1. One (1) Qualifier will be selected by random drawing from among valid entries received for the respective keyword, for a total of four (4) Qualifiers per weekday during the Contest Period.
2. Immediately following each Qualifier prize drawing, the Station will call the qualifier's phone number up to three (3) times within a five (5) minute window. As a condition of qualifying, the Qualifier must answer the Station's phone call, which may be aired on the Station. If the Qualifier cannot be immediately notified and does not answer the Station's phone call within the five (5) minute period, then such Qualifier will be disqualified, the prize will be forfeited, and an alternate Qualifier will be randomly selected from among remaining valid entries for the respective keyword. The foregoing process will repeat up to three times per Qualifier drawing.
3. On the Grand Prize Winner Drawing Dates, the Grand Prize Winner will be randomly selected from among the valid Qualifiers and will be notified via phone which may be aired on the Station. If winner does not respond to any communication for three (3) days, they will forfeit the prize, and a second winner will be drawn. Remaining valid entries will not carry over any future promotions.

Eligibility

Employees of Lotus Seattle Corp., Lotus Communications Corporation, Station (collectively, the "Company"), Sponsor(s), Prize Provider(s), TextGroove (Texting Code provider), each of their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. Contest Terms and Conditions

The Contest will be judged by Station personnel, and the decision of the judges will be final as to all matters, including (i) the order in which calls were received and (ii) whether any answer required to be given is correct. By calling the designated telephone line, each entrant gives permission to Station to record and/or broadcast contestant's telephone call. Poorly connected or disconnected cellular phone calls may be disqualified. Calls for entrants are taken in order of receipt. In the event that more than one voice is heard on the phone line, the winner will be the first person to speak. If the judge(s) is not able to determine which caller was first, a random drawing will be held to determine the winner. The use of switching or programming equipment by anyone is in violation of contest rules and is not permitted. Due to any time delay between the Station's on-air signal and the Station's online streaming, listeners of the Station's online stream may hear a cue to call later than those listening to the on-air signal. As a result, the odds of an online/mobile viewer being able to enter or become a winner may be diminished.

3. Station cannot be held liable for any lost or stolen entries, prizes or contest information. Station is not responsible for any technological malfunction, or human error relating to the Contest.
