Qualifying Prize(s) and Value(s): Prize and value depends on contest week. Please see winner paperwork for prize and value. Prizes will be valued between \$15 and \$500.

Participants must have a valid email and smart phone, in case of winning tickets that can only be claimed digitally. In this case, tickets can only be claimed through email and used at venue via smart phone. The process to claim and use tickets is as follows: Seattle Lotus Promotions department will send ticket link(s) to the winner's email. Winner must open email on a smart phone and click on link(s), winner will then be directed to open the "AXS" or "Ticketmaster" app on their smart phone, where they will see the digital barcode they must present at the venue. If winner does not have the app, then the winner must download the app and create a profile. Winners cannot attempt to print ticket link or ticket code if the ticket is digital because it will not be accepted at venue.

Participant must have access to a digital device capable of downloading and viewing their movie. If the digital download movie code expires without use, no substitutions or different codes given.

Participant must be willing to show ID to collect will call tickets.

No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value. ### **How to Enter**

## **How to Win**

The qualifiers will be selected by random drawing on each day of Contest Dates, from valid entries received. Entrants will have their name announced On-Air, and should call 206- 421-1015 within 10 minutes of hearing their name on the radio. If more than 10 minutes pass without a call, the station will call the phone number provided. If the winner does not answer after two tries, the prize will still be awarded, and they will be entered for the chance to win, as described in the General Rules. Winner must contact the station at some point before the end of the day with a minimum of their name, phone number, email address, birthday, home address and zip code to be eligible for their win. The remaining valid entries will not carry over to future contests.

*Each of the 38 stations will randomly select a daily qualifier from its entrants (with respect to each station, that station's "Station Entrant").*

*Each market will then choose one finalist from their combined daily entries to be entered into the daily Grand Prize drawing of \$2024. Of the remaining 9 Grand Prize finalists one will be selected in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday's winner will be notified on Monday).*
