Lotus HANK Network Group Contest

Contest Dates: April 27, 2026 – May 1, 2026 (the promotion period)

HOW TO ENTER/WIN:

To participate, listeners must do the following:

VIA MOBILE APP – During the promotion period, an opportunity to enter to win is provided on the 101.5 HANK FM free mobile app. Listeners may qualify only once per day.

a. For entry into the contest via the KPLZ mobile app, listeners will complete form available inside the app (free in all platform app stores).

b. Respondents will be asked to provide their full name, email address and birth date. Respondents may enter UP TO one time each single day.

c. Individual odds of qualifying increase by the number of unduplicated entries submitted during the week; duplicate entries within a single day are not permitted. Overall odds of winning depend on the number of eligible entries submitted for that week.

KPLZ Qualifier Selection -

- a. Friday 5/1/26, KPLZ will select one qualifier at random from among the daily winners. That finalist will be that week's grand prize drawing.
