

KPSL –La Ruleta de Ritmo

No Purchase or Obligation Necessary to enter or win.

CONTEST DESCRIPTION:

Registration: Beginning Monday May 5 through Friday June 13 2025 (Contest Period)

Requirements: Listeners of **Ritmo FM (96.5FM)** who are legal residents of the United States residing within the Kern County, CA metropolitan area will be able to take part in the **“La Ruleta de Ritmo” Giveaway Contest.**

HOW TO ENTER/WIN:

Starting Monday, May 5th through Friday, June 13th, tune in to **Ritmo FM** Monday through Friday between **6 AM and 6 PM**. Once a day, the DJ will open the phone lines and ask for **caller number 9**. If you are caller 9, you’ll get the chance to spin **La Ruleta de Ritmo** live on air!

Every spin wins! The prize wheel is loaded with rewards including **\$25 gift cards** and family 4 pack of **theme park tickets** (LEGOLAND, SIX FLAGS, SAND DIEGO ZOO AND SEA WORLD). One space on the wheel holds the **weekly cash grand prize**, which changes each week of the promotion. Over the course of six weeks, the cash prize will vary between **\$200 and \$1,000**.

If you become a cash prize winner, you must wait 30 days before becoming eligible to win again. If you are not the grand prize winner, you are allowed to play again during the week.

Limit one play per person per week during the contest.
