Lotus Summer of Fun Promotion General Contest Rules

No Obligation or Purchase Necessary

<u>Contest Dates</u>: June 26, 2023 – August 18, 2023

<u>Description of Contest</u>: The 36 radio stations (each, a "**Station**") in the nine markets identified below (each, a "**Contest Area**") will conduct the Lotus Summer of Fun Promotion (the "**Contest**"). If you wish to participate in the Contest, review the local contest rules below for that Station's Contest Area, which include instructions on how to enter that Station's weekly random selection.

Each of the 36 stations will randomly select a weekly winner from its entrants (with respect to each station, that station's "Station Entrant"), and those 36 winners will be entered into a random weekly drawing for one of the following trips for the winner and the winner's quest (the "Guest"). You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win. Once the Grand Prize winner has been selected all entries from that weekly contest will be discarded and registration will begin again for the next Grand Prize.

CONTEST DESCRIPTION:

Registration: June 26th – August 21st, 2023

Requirements: To enter, you must be a Idaho resident 21 years of age or older and have a valid Idaho Driver's License or Government Issued photo Identification Card, and a valid social security number.

HOW TO ENTER/WIN:

To participate, listeners must do the following:

- 1. From June 26th, 2023 through August 18th, 2023 listeners will be prompted to call on or around 7:30a, 11:30a, and 4:30p each Monday-Friday to play a travel themed trivia contest. The first contestant to successfully answer the trivia question will be entered into the weekly drawing to be selected as the KQXR grand prize qualifier for the current week's trip.
- 2. Listeners may qualify only once per week.
- 3. On or around 6pm MDT each Friday one qualifier will be selected to be entered into the grand prize drawing.

ELIGIBILITY RESTRICTIONS:
