Official Rules for Boise Radio Broadcast Giveaway

- b. Each eligible individual may enter the contest only once each day throughout the Sweepstakes. Multiple entries from the same person will be disqualified.

4. PRIZE:

- a. One (1) prize will be awarded. The prize consists of two hundred dollars (\$200 USD) in the form of cash.
 - b. The prize is non-transferable and non-exchangeable.
