

KQXR Frogger Official Contest Rules

No Purchase or Obligation Necessary to enter or win. Making a purchase does not increase the chances of winning.

CONTEST DESCRIPTION:

Contest Period: May 10, 2024 starting at 5p MDT and last contestant allowed to compete will be by 7:30pm MDT. Contesting ends at 7:31pm MDT unless a contestant is still actively competing, in which case contest will end once the final contestant reaches a "Game Over".

Requirements: Must be 18 years of age or older with a have a valid US state driver's License or Identification Card. Limit one entry per person.

HOW TO ENTER/WIN:

Listeners of KQXR who are legal residents of the 48 contiguous United States and are 18 years of age and older will be able to take part in the KQXR Frogger Contest. To participate in the KQXR Frogger Contest, listeners must do the following:

1. Be present on site of contesting located at Spacebar Arcade (620 W Idaho St Suite 100, Boise, ID 83702) to compete in contesting
2. Contestants will be provided one opportunity to play the arcade game Frogger on site. No practice runs are allowed.
3. The top 3 contestants with the highest score that are present at the end of contesting will be declared the winners. The highest scoring winner will have his choice of one of the three prizes. The second highest scorer will be presented a chance to select of the remaining two prizes, and the third highest scorer will be awarded the final prize remaining.
4. In the event of power disruption during contesting: If power is promptly restored during contesting period, then contestant will be allowed another chance to compete.

ELIGIBILITY RESTRICTIONS:

1. The KQXR Frogger contest is open to adults 18 years of age and older possessing a valid United States driver's license and are legal residents of the 48 contiguous United States.
2. Employees of KQXR, KRVB, KTHI and KJOT, Boise Lotus Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Boise, Idaho metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KQXR Frogger Contest. For purposes of this KQXR Frogger Contest, the term immediate family

member is defined as spouses, parents, grandparents, children, and siblings and their respective spouses.

PRIZES:

1. The prizes to be awarded are a pair of tickets to the following concerts: Static X/Sevendust at the Knitting Factory 5/11/24, Asking Alexandria at the Revolution Concert House on 5/11/24, and X-Fest on 8/18/24 at the Idaho Center.
2. No substitution of prize is offered unless show is cancelled, in which case KQXR may offer a different concert opportunity to replace tickets.
3. Prizes will be awarded only upon winner verification and final approval by KQXR.
4. All KQXR Frogger Contest winners must sign and date official station release and waiver forms as requested at time of pick up. Failure to do so will result in winner forfeiting the prize.
5. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of the KQXR Frogger Contest administrator if another entrant is to be selected as the winner if time permits.
6. In the event any winner is found to be in violation of these Official Rules or is otherwise determined by KQXR, in its sole discretion to be ineligible, he/she may be required to forfeit the prize or to reimburse KQXR and / or any sponsor for the stated value of the prize if such a violation is found after the prize has been used by winner.
7. Participants must have a valid email and smart phone, in case of winning the prize; some tickets can only be claimed through email and used at venue via smart phone. The process to claim and use tickets is as follows: Boise Lotus Promotions department will send ticket link(s) to the winner's email. Winner must open email on a smart phone and click on link(s), winner will then be directed to open the "Ticketmaster" app on their smart phone, where they will see the digital barcode they must present at the venue. If winner does not have the "Ticketmaster" app, then the winner must download the app and create a profile. Winners cannot attempt to print ticket link or ticket code because it will not be accepted at venue.

GENERAL CONDITIONS:

1. Winners are responsible for all applicable taxes associated with the receipt of the prize.
2. Any person winning over \$600.00 in prizes in a calendar year will receive an IRS form 1099 at the end of the calendar year for tax purposes and a copy of such form will be filed with the IRS as required by law.
3. No purchase necessary. Contest is void where prohibited. Contest is subject to all applicable federal, state and local laws and regulations

4. Odds of winning depend upon the number of eligible contestants participating during the Contest Period.
5. By participating in the KQXR Frogger Contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest, in any media now known or hereafter devised for advertising or promotional purposes without additional compensation, and must sign a publicity release prior to acceptance of the prize. By entering this KQXR Frogger Contest, each participant agrees to comply with the Official Rules and the decisions of the contest sponsor which shall be final and binding in all aspects relating to the KQXR Frogger Contest.
6. All contest winners will be required to sign a liability release prior to acceptance of any prize. 10. WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations. KQXR Double Dare Contest participants should not rely on streamed broadcasts to participate in the KQXR Double Dare Contest.

KQXR and Boise Lotus Corp., participating sponsors and their respective parent companies, subsidiaries, affiliates or their representatives, agents and employees are not responsible for the inability of any contestant to complete or continue a telephone call, facsimile transmission or internet registration due to equipment malfunction, busy lines, inadvertent disconnections, unavailable network, server, Internet Service Provider (ISP) or other connections, communication failures or human error that may occur in the transmission, receipt or processing of entries.
