## CONTEST DESCRIPTION:

Registration: Register between September 1<sup>st</sup>, 2025 at 11:59p.m. MST and December 31<sup>st</sup>, 2025 at 11:59p.m. MST, through contest site, hosted on <a href="https://www.xrock.com">www.xrock.com</a>

Requirements: To enter, you must be an Idaho resident, 21 years of age or older and have a valid Idaho Driver's License or Government Issued photo Identification Card, and a valid social security number.

Weekly Prize: \$5 gift certificate (valid at all three Idaho McCleary's locations) and a 10 Barrel swag bundle (estimated value of \$50). Total value of the weekly prize is \$55.
