NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

PRIZES

- a. There are ten (10) prizes total, one prize per chosen household. Each prize varies, depending on what the nomination form indicates that the household needs. The base value of each prize is \$1,000, with the possibility of additions to the base prize. Each winner will be notified of the final value of their prize upon delivery.
- b. There is no substitution, transfer, or cash equivalent for prize, except that Promoter may, at its sole discretion, substitute prize of comparable value or cash. The prize is expressly limited to the items listed above and do not include taxes, gratuities, or any other expenses. Promoter is not responsible for winner's limitations that prevent acceptance, use, or nonuse of prize. 2. PROMOTION DATES

a. These rules (the "Official Rules") govern the Lotus Wish Upon a Star ("Promotion"), which will begin on November 18^{th} at 6:00 a.m. Mountain Standard Time ("MST") and will be concluded by December 19^{th} at 10:00 a.m. MST.

3. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all legal U.S. residents who are 21 years of age or older at the time of nomination and who live in the Boise Designated Market Area, as that term is defined by The Nielsen Company (the "Promotion Area"). Members of the winning household are not required to be 21 year of age or older. Employees of Lotus Boise Corp. 4. ENTRY

CONDITIONS APPLICABLE TO ALL ENTRIES

- a. Entries submitted will not be acknowledged or returned and will be the property of Promoter. Use of any device to automate entry is prohibited. All entry information must be accurate. Proof of submission of an entry will not be deemed proof of receipt by Promoter. The Promotion administrator's computer is the official time keeping device for the Promotion.
- b. A household is only eligible to win one time during this Promotion.
- c. Nomination forms must be complete and must provide a truthful reason for the nomination.

6. WINNER SELECTION AND NOTIFICATION

- a. Ten (10) submissions will be vetted and selected by internal Lotus Boise staff members and reviewed by a select Rogue Credit Union committee by 11:59pm MST on December 10th, 2025.
- b. Each winner will be notified by phone call/in-person visit of their selection sometime between December 10th, 2025 and December 19th, 2025.

7. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. Winner will be required to complete and submit an IRS Form W-9 or the equivalent including the winner's full Social Security Number for receipt of any prize valued at \$600 or more or for any prizes awarded by Promoter in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in disqualification and forfeiture of the prize.
- b. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals; or any other difficulties that may prevent an individual from entering or participating, or (iii) lost, stolen, mangled, misdelivered, misdirected, illegible, incomplete, incorrect, or late entries.
