

Metallica At The Sphere 2026 Rules

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. GRAND PRIZE

a. There is one Grand Prize. The Grand Prize consists of two tickets to Metallica in Las Vegas, NV at The Sphere on October 31st, 2026, plus airfare for two and hotel accommodations. Winner is responsible for own ground transportation and food. (Estimated value of grand prize is approximately \$3500)

b. There is no substitution, transfer, or cash equivalent for prize, except that Promoter may, at its sole discretion, substitute prize of comparable value or cash. The prize is expressly limited to the items listed above and do not include taxes, gratuities, or any other expenses. Promoter is not responsible for winner's limitations that prevent acceptance, use, or nonuse of prize. Entrants acknowledge that the Released Parties, as defined herein, have not made, nor are in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties expressed or implied, in fact or in law, whether now or hereafter enacted concerning the prize, including without limitation, implied warranties of quality, merchantability, mechanical condition, or fitness for a particular purpose, except for any express manufacturer's warranty as may be included with the prize or as may be separately provided to participants by law.

c. The Grand Prize is not refundable or transferable and may not be substituted or exchanged for cash or credit at any time, nor will such gift cards be replaced if unused, lost, stolen, or damaged.

2. PROMOTION DATES

These rules (the "Official Rules") govern the Metallica At The Sphere ("Promotion"), which will begin on May 4th, 2026 at approximately 7:30 a.m. Mountain Time ("MT") and will be concluded by May 29th, 2026 at 7:30pm MT.

3. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all legal U.S. residents who are 21 years of age or older at the time of entry and who live in the Boise Designated Market Area, as that term is defined by The Nielsen Company (the "Promotion Area"). Winner and guest must be at least 21 years of age (unless immediate family member of winner). Employees of Lotus Boise Corp. (the "Promoter"), d/b/a KQXR/100.3 the X (the "Station" their parents, subsidiaries, and affiliated entities, the Promotion sponsors (Dennis Dillon), advertising agencies, and promotion agencies, any other third party involved in the development or administration of the Promotion, other broadcasting stations in the Promotion Area, and the members of those individuals' immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. Void outside the United States and outside the Promotion Area. b. Entrants are required to provide truthful information, and Promoter will reject and delete any entry that it discovers to be false or fraudulent. Promoter will disqualify any entry from individuals who do not meet the eligibility requirements if discovered by Promoter.

c. Participants must have a valid email and smart phone, in case of winning a prize; some tickets may only be claimed through email and used at venue via smart phone. The process to claim and use

tickets is as follows: Boise Lotus Promotions department will send ticket link(s) to the winner's email or via text to their cell phone. Winner must open email on a smart phone and click on link(s), winner will then be directed to open the promoter's app on their smart phone, where they will see the digital barcode they must present at the venue. If winner does not have the promoter's app, then the winner must download the app and create a profile. Winners cannot attempt to print ticket link or ticket code because it will not be accepted at venue.

4. ENTRY

You may participate in the Promotion via the following methods:

ON-AIR

- a. Every weekday through the promotion (Monday through Friday) at 7:30am, 12:20pm, and 5:30pm, listeners will be prompted to call to answer a True or False question about the band, Metallica
- b. After each question has been played, the on-air announcer will solicit the caller (to call 208-287-1003) to correctly answer the question. Only one caller will get an opportunity to answer each question, for a total of 3 times per day until promotion has ended.
- c. Caller will get one chance and must answer a question correctly to qualify for the Grand Prize drawing. Callers who answer incorrectly will not be qualified for the Grand Prize drawing.
- d. Individuals can only qualify once during this promotion.

IN-PERSON

- a. On May 16th, 2026, 100.3 The X will be on-site at Dennis Dillon Mitsubishi (9380 W Fairview Ave, Boise, ID) from 4pm to 6pm MST. Individuals who are present at the remote broadcast can complete an "enter to win" form, asking for their full name, phone number, and birth date. Every 30 minutes, one qualifier will be randomly selected from the bin of forms, with two qualifiers being selected at 6pm MST. There will be a total of 5 on-site qualifiers entered into the general qualifier pool.
- b. On May 29th, 2026, 100.3 The X will be on-site at Dennis Dillon Pre-Owned Supercenter (9176 W Fairview Ave, Boise, ID) from 5pm to 7pm MST. Individuals who are present at the remote broadcast can complete an "enter to win" form, asking for their full name, phone number, and birth date. Every 30 minutes, one qualifier will be randomly selected from the bin of forms, with two qualifiers being selected at 7pm MST. There will be a total of 5 on-site qualifiers entered into the general qualifier pool.

5. CONDITIONS APPLICABLE TO ALL ENTRIES

- a. Entries submitted will not be returned and will be the property of Promoter. Use of any device to automate entry is prohibited. All entry information must be accurate. Proof of submission of an entry will not be deemed proof of receipt by Promoter. The Promotion administrator's computer is the official time keeping device for the Promotion.

6. QUALIFIER AND WINNER SELECTION AND NOTIFICATION

- a. The Grand Prize winner will be randomly selected from the list of Qualifiers on June 1st, 2026. The total number of Qualifiers is dependent on how many individual callers get a question correct when they are answering during the promotion. At a maximum, there will be 70 Qualifiers. Odds of being the Grand Prize winner depends on the number of Qualifiers.

b. Each potential Qualifier may be required, in Promoter's sole discretion, to complete and return an Affidavit of Eligibility, a scan or photo of legal ID, Release of Liability and/or a Publicity Release before being allowed to participate in the Grand Prize selection event at the Event. If required, all forms must be completed and returned prior to the Grand Prize selection portion of the Event. Noncompliance within this time period, failure to comply with the Official Rules (including eligibility requirements), failure to respond within 24 hours of initial notification attempt (for potential Qualifiers) may result in disqualification and forfeiture of opportunity to receive Grand Prize. If a potential Qualifier is disqualified, Promoter may, at its discretion, choose a replacement Qualifier by random drawing from remaining eligible, non-winning entries. All decisions of Promoter management with respect to the Promotion are final.

c. If the Grand Prize winner has not already completed and returned an Affidavit of Eligibility, a scan or photo of legal ID, Release of Liability and/or a Publicity Release, Grand Prize winner may be required to do so prior to receipt of Grand Prize. If Grand Prize winner fails to do so by the deadline established by Promoter or fails to comply with the Official Rules (including eligibility requirements), winner will be disqualified, the Grand Prize will be forfeited, and the Grand Prize may, at Promoter's discretion, be awarded to the runner up from the reverse drawing. Properly claimed prize will be awarded, but in no event will Promoter award more prizes than are provided for in these Official Rules.

d. Grand Prize winner will be contacted by 12pm MST on June 1st via phone, email, or text to notify them of their selection.

7. CONDITIONS

a. Payments of all federal, state and local taxes are solely the responsibility of the winner. Winner will be required to complete and submit an IRS Form W-9 or the equivalent including the winner's full Social Security Number for receipt of any prize valued at \$2000 or more or for any prizes awarded by Promoter in a calendar year with an aggregate value of \$2000 or more. Failure to submit a complete W-9 or equivalent will result in disqualification and forfeiture of the prize.

b. Participating in the Promotion and acceptance of the prize constitutes each Qualifier's permission for the Promoter or its agents to photograph, film, record that Qualifier and to use his or her name, city, state, voice, or likeness, and any statements made by him or her regarding the Promotion or its Promoter or Prize Providers for purposes of trade, publicity or promotion in connection with the Promotion without additional financial or other compensation, and to sign a publicity release confirming such consent prior to acceptance of the prize.

c. By entering, participating and/or accepting the prize in the Promotion, each entrant and Qualifier agrees not to sue and to release, discharge, indemnify, hold harmless, and absolve the Promoter, Prize Providers, the Promotion sponsors, advertising agencies, and promotion agencies, and any third party involved in the development or administration of the Promotion, and each of their respective parent, subsidiary and affiliated entities and the officers, shareholders, directors, employees, agents, and representatives and the successors and assigns of each of them (the "Released Parties") from and against any and all claims, demands, actions, suits, losses, expenses, costs, damages, and liabilities including, without limitation, interest, penalties, court costs and reasonable attorneys' fees and expenses arising directly or indirectly from the prize or participation in the Promotion, including, but not limited to, personal injury, death, or damage to or loss of property, which may occur in connection with, preparation for, travel to, or participation in Promotion, or possession, acceptance and/or use or misuse

of prize or participation in any Promotion-related activity, including but not limited to any claims based on publicity rights, defamation, or invasion of privacy and merchandise delivery.

d. Promoter, in its sole discretion, reserves the right to disqualify any person (and all of that person's entries) from this Promotion if he or she tampers with the entry process, the operation of the Promotion, or is otherwise in violation of the Official Rules or direction of Promoter. If a dispute arises regarding compliance with these Official Rules, Promoter may consider, in its sole discretion, data reasonably available to Promoter through information technology systems in Promoter's control, but Promoter will not be obligated to consider any data or other information collected from any other source. Promoter's failure to enforce any term of these Official Rules will not constitute a waiver of this provision. If there is a conflict between any term of the Official Rules and any marketing or entry materials used in connection with the Promotion, the terms of these Official Rules will govern. If because of circumstances beyond the control of Promoter, the Event is delayed, rescheduled, postponed or cancelled, Promoter reserves the right, but not the obligation, to modify, suspend, or cancel the Event and choose the winner by random drawing from among the on-air, Remote, any on location qualifiers, and Promoter will announce its action on-air on all of the Stations.

e. For those viewing/listening to the Station stream on the Internet or other non-broadcast means: Please be advised that you may be listening to a delayed stream of the broadcast signal, which may vary depending on your computer's memory capacity and your connection. For that reason, we strongly recommend that you turn on your radio to the Station to participate in this or any other call-in contest to be sure you are participating in "real time." The Stations assume no responsibility for participants not making timely phone calls to a Station as a result of the delays in the method of viewing/listening.

f. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals; or any other difficulties that may prevent an individual from entering or participating, or (iii) lost, stolen, mangled, misdelivered, misdirected, illegible, incomplete, incorrect, or late entries. Further, the Released Parties are not responsible if any part of a promotion prize that cannot be awarded due to acts of God, acts of war, natural disaster, weather, acts of terrorism or other factors beyond the Station's control.

EXCEPT WHERE PROHIBITED, ENTRANTS AGREE THAT ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROMOTION, OR PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY WITHOUT RESORT TO ANY FORM OF CLASS ACTION AND ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED BY ENTRANT WITH REGARD TO THIS PROMOTION, BUT IN NO EVENT ATTORNEYS' FEES, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrants and Promoter in connection with the Promotion will be governed by and construed in accordance with the laws of the State of Ohio, without giving effect to any choice of law or conflict of law rules or provisions (whether of Ohio or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than Ohio.
