CONTEST DESCRIPTION:

Registration: Submit a photo of your dog by 11:59p.m. MST on September 7th, 2025, to be entered into the contest

Requirements: To enter, you must be an Idaho resident, 21 years of age or older and have a valid Idaho Driver's License or Government Issued photo Identification Card, and a valid social security number.

Grand Prize: Gift basket of dog treats, toys, and accessories- valued at \$200. Optional - feature with their dog onstage at See Spot Walk event on October 4th, 2025.

HOW TO ENTER/WIN: To participate, listeners must do the following:

- 1. Submit a photo of your dog by 11:59p.m. MST on September 7th, 2025, to be entered into the contest. Limit one photo entry per participant. All photo submissions are property of the station. Participants must send their photo through the contest site on riverboise.com
- 2. An internal committee of six (6) Lotus Boise staff members will select sixteen (16) submissions, based solely on the photos provided, to be placed in a public bracket, made public on September 11th at 7a.m. MST. Committee members will vote on all submissions and provide a "cuteness" score from 1 to 5 (5 being the "cutest"). The sixteen (16) photo submissions with the highest cumulative scores will be placed in the public bracket. In the event that there are photo submissions that are tied in score, there will be a random drawing to select which photo(s) will be placed in the public bracket.
- 3. Starting matchups will be randomly assigned and public voting will take place to determine which submissions move forward in the competition. The timeline for rounds is below:

ROUND 2: September 16th - September 21st

ROUND 3: September 22nd - September 28th

ROUND 4: September 29th - October 2nd
