# Lotus Summer of Fun Promotion General Contest Rules 2024

# No Obligation or Purchase Necessary

Winner and Guest must be 21 years of age or older

Contest Dates: June 17, 2024 - August 9, 2024

<u>Description of Contest</u>: The 34 radio stations (each, a "**Station**") in the nine markets identified below (each, a "**Contest Area**") will conduct the Lotus Summer of Fun Promotion (the "**Contest**"). If you wish to participate in the Contest, review the local contest rules below for that Station's Contest Area, which include instructions on how to enter that Station's weekly random selection.

If prize winner refuses the prize and signs a release provided by its station, the prize winner will be paid \$3,000. Prizes are non-transferable.

Weekly winners will be chosen at random on Fridays at approximately 6pm local time and will be entered into the weekly Grand Prize drawing that will take place on the following Monday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will a have one year from the date on which that prize winner was notified to claim and use the prize. After one-year, the prize will be forfeited. Trips may have blackout dates. It is the responsibility of the prize winner to ensure that the prize is used during the one-year period. Winner must have a valid credit for incidentals.

If we are unable to contact the winner after 5 days from the time their name was drawn another winner will be chosen.

## Eligibility:

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

#### **CONTEST DESCRIPTION:**

Registration: June 17th – August 9st, 2024

**Requirements**: To enter, you must be a Idaho resident 21 years of age or older and have a valid Idaho Driver's License or Government Issued photo Identification Card, and a valid social security number.

#### **HOW TO ENTER/WIN:**

To participate, listeners must do the following:

VIA TEXT – From June 17<sup>th</sup>, 2024 through August 9<sup>th</sup>, 2024 during the promotion period, each weekday at approximately 9am, 11am, 1pm, and 3pm a key word will be announced on the station. Listeners may qualify only once per week.

- a. For entry into the contest via the KRVB studio line, listeners will text the keyword as announced to 208-287-2949. For entry into the contest via the KTHI studio line, listeners will text the keyword as announced to 208-287-5107. For entry into the contest via the KJOT studio line, listeners will text the keyword as announced to 208-287-5105
- b. On submission of the first keyword, respondents will be asked to provide their full name, email address and birth date. Once registered, respondents' future entries will simply be acknowledged in a reply text.
- c. Station may add additional entry opportunities on specific days and times during the promotional period. In these cases, the day's additional keyword will be displayed on signage at a remote location for a specific amount of time. The remote location and time will be promoted on the station, and station's website.
- d. Respondents may enter UP TO four keywords on any single day except for days in which a "Remote Entry" is displayed. In these cases, respondents may enter UP TO five Keywords on that day for that contesting week.
- e. Individual odds of qualifying increase by the number of unduplicated keywords submitted on any single day; duplicate keyword entries within a single day are not permitted. Overall odds of winning depend on the number of eligible entries submitted for that week.
- f. Each week represents an entirely new contest; entries are not retained.

**Lotus Boise Market Qualifier Selection**. Each Week, each Lotus Boise Station (KJOT/KTHI/KRVB/KQXR) will select one qualifier at random from among their station's entries by 6pm on Friday of each contesting week and that finalist will be that week's Summer of Fun grand prize drawing.

**Grand Prize Drawing.** The Boise finalist will be one of thirty-four entries, one per participating station. One Grand Prize Winner will be drawn at random from among the nine finalists

### **ELIGIBILITY RESTRICTIONS:**

1. If Promoter does so, Promoter will not pick additional telephone Qualifiers after the termination and will announce its action on air.

For those viewing/listening to the Station stream on the Internet or other non-broadcast means: Please be advised that you may be listening to a delayed stream of the broadcast signal, which may vary depending on your computer's memory capacity and your connection. For that reason, we strongly recommend that you turn on your radio to the Station to participate in this Promotion to be sure you are participating in "real time." The Station assumes no responsibility for entrants not making timely entries to the Station as a result of the delays in the method of viewing/listening.
- g.
