

SUPERIOR GROCERS' CAR GIVEAWAY SUMMER 2025 KWID

CONTEST DESCRIPTION:

Registration: Wednesday, July 23., 2025 – Sunday, August 31, 2025. The Grand Prize Giveaway date is Saturday, September 13, 2025.

Requirements: To enter, you must be a Nevada resident, 18 years of age or older and have a valid Nevada Driver's License, proof of current automobile insurance and proof of a valid social security number or ITIN

Grand Prize: Grand Prize winner will win a 2025 Nissan Sentra VIN# 3N1AB8CVXSY220496 including tax, title and a \$500 check to cover the cost of vehicle registration. The total value of the grand prize is \$26,500 provided by Superior Grocers and Lotus Broadcasting Corp. for promotional purposes.

HOW TO ENTER/WIN:

1. From Wednesday, July 23, 2025 – Sunday, August 31, 2025, listeners will be instructed to register to win the grand prize at Superior Grocers at 390 S Decatur Blvd, , Las Vegas, NV., 89107 during business hours. Contestants may enter by scanning the LA BUENA 101.9 UPC code with their smart phone. The UPC code will be prominently displayed in the store. Once scanned, they will be required download the La Buena 101.9 APP to their smart phone and create an account by submitting the requested information. They will then click the check in at Superior Grocers on the app to enter the contest. One entry per day allowed. Once their account is created, contestants may enter the contest a maximum of once per day by clicking check in on the La Buena 101.9 APP while at the Superior Grocers location at 390 S Decatur BLVD.
2. Five finalists will be randomly drawn from the app entries on 7/23, 7/27, 8/2, 8/9, 8/16, 8/23, and 8/31. Finalists will be notified by phone and/or email.

Five finalists will also be randomly drawn from the La Buena registration box at the La Buena broadcast table at each of the La Buena live remote broadcast activations on the above dates except on 7/23 and 8/31 when ten finalists will be randomly drawn from the broadcast table entries. Finalists will be notified via phone and/or email.

FINALISTS
