



## **KDOT – 30<sup>th</sup> Birthday Party Remote Giveaway**

### **Enter to Win Contest Rules**

*No Purchase or Obligation Necessary to enter or win.*

### **CONTEST DESCRIPTION**

**Registration:** On April 25<sup>th</sup> 2026 from 2:00 PM – 5:00PM

**Requirements:** Winner must be 21+ years of age or older and have a valid Nevada Driver's License or Government Issued Identification Card.

**Prizes:** (1) Pair of 4-Day VIP Passes to the Aftershock Music Festival (Approximate retail value of \$1882 (each pass valued at \$941)

**HOW TO ENTER / WIN:** Listeners of KDOT who are legal residents of the United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas will be able to take part in the **KDOT – 30<sup>th</sup> Birthday Aftershock Raffle taking place at 50/50 Brewing located at 299 E. Plumb Lane Suite 145 Reno, NV 89502**

To participate in the said contest, listeners must do the following:

1. Beginning Saturday April 25<sup>th</sup>, 2026 from 2:00 PM through Saturday April 25<sup>th</sup>, 2026 at 4:59PM Eligible participants must attend the Event in person and complete an official raffle entry form, including name, address, phone number, and date of birth.

Each eligible participant will receive one (1) raffle entry. Limit one (1) entry per person.

All entries must be submitted during the Event. Entries submitted before or after the Event will not be eligible.

2. At the conclusion of the Event, one (1) winner will be selected in a random drawing from all eligible entries received.

The selected entrant must be present at the time of the drawing to be declared the winner.

If the selected entrant is not present, that entrant will be disqualified and another entry will be drawn. This process will continue until a present, eligible winner is confirmed.

3. The potential winner must present valid government-issued identification and complete any required documentation at the Event.

The winner will receive a certificate and/or voucher at the Event confirming the prize.

The actual VIP passes (wristbands/tickets) will be distributed at a later date once received by the Station, anticipated in or around September 2026.

4. The winner must provide accurate contact information and agrees to coordinate with the Station for prize fulfillment. Failure to respond or claim the prize within a reasonable timeframe may result in forfeiture.

#### **ELIGIBILITY RESTRICTIONS:**

1. **KDOT – 30<sup>th</sup> Birthday Aftershock Raffle** is open to listeners of **KDOT** who are 21+ YEARS and older and are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.

2. Employees of KOZZ, KDOT, KXZZ, KTHX, KHIT, KFOY, KPLY, Reno Lotus Radio Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Reno/Tahoe metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this **KDOT – 30<sup>th</sup> Birthday Aftershock Raffle**. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.

In the event of cancellation or reschedule, for whatever reason, the contest becomes null and void and no future/further prize(s) will be awarded.

2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.

3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.
