



KDOT, KOZZ – Port of Subs – BIG Bite Bundle

No Purchase or Obligation Necessary to enter or win.

CONTEST DESCRIPTION

Registration: Beginning June 1st 2026 from 12:00 AM through Sunday June 14th, 2026 at 11:59PM.

Requirements: Winner 18+ years of age and have a valid Nevada Driver's License or Government Issued Identification Card.

Prizes: 2 Port of Subs "Big Bite Bundles" which each include a 6-foot sub, chip assortment (10 bags) & a Dessert Tray (feeds approx 10-15) – Big Bite Bundles are provided by Port of Subs for promotional purposes. 1 Big Bite Bundle will be awarded per station.

HOW TO ENTER / WIN: Listeners of KDOT & KOZZ who are legal residents of the 48 contiguous United States and residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas will be able to take part in the **KDOT & KOZZ – BIG Bite Bundle Text to Win Contest**. ELIGIBILITY RESTRICTIONS:

1. The **KDOT & KOZZ – BIG Bite Bundle Text to Win** is open to listeners of **KDOT & KOZZ** who are 18 years or older and are legal residents of the 48 contiguous United States & residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.
2. Employees of KOZZ, KDOT, KXZZ, KTHX, KHIT, KFOY, KPLY, Reno Lotus Radio Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Reno/Tahoe metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this **KDOT & KOZZ – BIG Bite Bundle Text to Win**.
