# KOZZ's Strange Trip: Dead & Company Live at Sphere July 11th Part 2

HOW TO ENTER/WIN: Listeners of KOZZ who legal residents of the 48 contiguous United States are residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas will be able to take part in the KOZZ's Strange Trip: Dead & Company Live at Sphere Part 2 Promotion. To participate in the said contest, listeners must do the following:

- 1.) Beginning Monday April 29th, through Friday May 24th, 2024 a KOZZ DJ will play a Grateful Dead sounder three times a day between 6a-7p. Caller #11 after the Sounder will get qualified. There will be a total of 15 qualifiers per week. The sixty qualifiers will be put into the random drawing to happen on Friday May 24th, 2024 in the 4pm hour for the pair of tickets for Grateful Dead: Dead Forever Live at Sphere in Las Vegas July 11th (valued at \$1,353) and the \$500 Gift Card. Winner will be notified by phone and email. One Grand Prize Winner to be awarded.
- 2.) In addition, each week, the fifteen qualifiers will have the opportunity to be entered in a random drawing for a chance to win a pair of Reno Aces Tickets (valued at \$35) for Grateful Dead Night Saturday July 11th for promotional

purposes. One pair per week will be given away on Fridays in the 3p hour by Max Volume.

Participants must have a valid email address and smart phone, in case of winning the prize; tickets can only be claimed through email and used at the venue via smartphone. The process to claim and use the tickets is as follows: The Lotus Radio Promotions department will send ticket link(s) to the winner's email.
