

Wild Island Bowl & Bash Giveaway Contest Rules

No Purchase or Obligation Necessary to enter or win.

Registration: Beginning Monday September 22nd, 2025 - Friday October 3rd, 2025

Requirements: Winner and guest must be 21+ years of age or older unless it is an immediate family member and have a valid Nevada Driver's License or Government Issued Identification Card.

Prizes:

Qualifying Prizes: (10) Ten Pairs of Unlimited All-Day Access Wristbands. (10 qualifiers)

Grand Prize: (1) One Ultimate Company party at Coconut Bowl which includes Four private bowling lanes for 2 hours (up to 30 guests), shoe rental for 30 guests, Unlimited Soda service during the event, One hour of food service with banquet options for up to 30 guests. Options include Taco or Fajita bar.

Restrictions: Prize is Non-transferable and has no cash value. Event cannot exceed 30 guests; final guest count due 14 days in advance of event. Alcoholic beverages not included. Must be booked by January 31, 2026 and held between November 1, 2025 - March 31, 2026 (subject to availability). If not booked by January 31, 2026 certificate and prize are void

Methodology: Listeners of KOZZ who are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas will be able to take part in the **Wild Island - Bowl & Bash Giveaway**. To participate in the said contest, listeners must do the following:

1.) Beginning Monday September 22nd through Friday October 3rd, 2025 a KOZZ DJ will prompt listeners to be caller Eleven at (775) 737-5699 to participate. KOZZ DJ will then do a trivia contest where they will ask three questions to the participant. If the participant gets 3 correct questions or a "Turkey" (bowling term) they will qualify and win a pair of Unlimited All-Day Access Wristbands to Coconut Bowl at Wild Island located at 1855 E Lincoln Way, Sparks, NV 89434. If they don't get all 3 correct, they'll be given an extra question, a "spare" (bowling term) to qualify. If the participant does not answer the 3 questions or the extra

question correct, KOZZ DJ will ask for another participant. All participants who answered the questions correctly are considered qualifiers and will be entered into the random drawing to happen Friday, October 3rd around 2:00pm to win the Grand Prize Ultimate Company Party at Coconut Bowl (valued at \$1200). ELIGIBILITY RESTRICTIONS:

- 1. The **Wild Island Bowl & Bash Giveaway** Contest is open to listeners of KOZZ who are 21+ YEARS and older and are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.
- 2. Employees of KOZZ, KDOT, KXZZ, KTHX, KHIT, KFOY, KPLY, Reno Lotus Radio Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Reno/Tahoe metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this **Wild Island Bowl & Bash Giveaway.** For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
