

KOZZ Money Clips - 2025 Official Contest Rules

No Purchase or Obligation Necessary to enter or win.

Registration: Beginning Monday September 29th, through Friday November 21st, 2025.

Requirements: Winner must be 21+ years of age or older and have a valid Nevada Driver's License or Government Issued Identification Card.

HOW TO ENTER/WIN: Listeners of KOZZ who are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas will be able to take part in the **KOZZ- Money Clips 2025 Contest.** To participate in the said contest, listeners must do the following:

- 1. From Monday September 29th, through Friday November 21st, 2025 listeners will be instructed to listen for the on-air "Money Clips" audio clue weekdays during the 7am hour, 11am hour and 3pm hour. Listeners will hear an audio clip of three songs from the Classic Rock genre on-air on 105.7 KOZZ.
- 2. Caller #11 during the 7am hour that guesses ALL three artists and song titles correctly in the correct order they are played in the clip, will win \$100.00. If the correct answer is not given, the \$100 carries over into the next day part contest time and the new #11 caller has the opportunity to win the rolled over amount.
- 3. The prize money will rollover to the following weekday if there is no winner during the day the contest is being conducted.
- 4. The contest ends on Friday November 21st, at 3pm with the possibility of no winner. Maximum potential of total prize monies is \$12,000.

5. Listeners are only eligible to win prize money once during the promotional period between 09/29/25 through 11/21/25 for the Money Clips promotion on 105.7 KOZZ.

ELIGIBILITY RESTRICTIONS:

- 1. The **KOZZ Money Clips 2025 Contest** is open to listeners of KOZZ who are 21+ YEARS and older and are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.
- 2. Employees of KOZZ, KDOT, KXZZ, KTHX, KHIT, KFOY, KPLY, Reno Lotus Radio Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Reno/Tahoe metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this **KOZZ Money Clips 2025 Contest.** For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
- 3. Persons who have won a prize in another contest or promotion of any kind from Reno Lotus Radio Corp. Across all stations within the fourteen (14) day period immediately preceding the start date of **KOZZ-Money Clips 2025 Contest** are not eligible to participate. Only one person per family or household (whether related or not) may win any promotion from Reno Lotus Radio Corp during any fourteen (14) day period.

PRIZES:

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KOZZ and Reno Lotus Radio Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KOZZ and Reno Lotus Radio Corp. are not obligated to make any effort to find an alternative prize under these circumstances. In the event of cancellation or reschedule, for whatever reason, the contest becomes null and void and no future/further prize(s) will be awarded.

- 2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
- 3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.
- 4. Prizes will be awarded only upon winner verification and final approval by Reno Lotus Radio Corp.
- 5. The **KOZZ- Money Clips 2025 Contest** winners must sign and date official station release and waiver forms as requested. Failure to do so will result in the winner forfeiting the prize.
- 6. Winners will be award their prize winnings by check, checks can take 4-6 weeks for delivery.
- 7. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of The **KOZZ- Money Clips 2025 Contest** sponsor and / or the contest administrator if another entrant is to be selected as the winner if time permits.
- 8. In the event any winner is found to be in violation of these Official Rules or is otherwise determined by KOZZ, in its sole discretion to be ineligible, he/she may be required to forfeit the prize or to reimburse KOZZ and /or any sponsor for the stated value of the prize if such a violation is found after the prize has been used by winner.
- 9. If the winner is unable to pick-up or redeem their prize, there will be no transfer of said prize to another party for pickup or redemption.

GENERAL CONDITIONS:

- 2. Any person winning over \$600.00 in prizes will receive an IRS form 1099 at the end of the calendar year for tax purposes and a copy of such form will be filed with the IRS as required by law.

- 9. So long as no participant is materially adversely affected, KOZZ reserves the right to make changes in the contest rules, which will become effective upon being announced on the air and / or posted online.

KOZZ and Reno Lotus Radio Corp. its subsidiaries, its affiliates, participating sponsors and any other promotional parties will not assume any responsibility for any changes in the execution of the contest, including; cancellation of the contest as a result of the occurrence of events not within the control of the KOZZ and Reno Lotus Radio Corp, its subsidiaries, affiliates, participating sponsors, promotional partners and other radio stations, such as acts of nature, strikes, terrorists acts or criminal acts of third parties. In the event such an act should occur,

KOZZ may, in its sole discretion, offer the winner a comparable prize(s) currently being offered by KOZZ in lieu of the Prize originally awarded.
