



Diamond Peak Text to Win Giveaway Contest Rules

No Purchase or Obligation Necessary to enter or win.

Registration:

Beginning Monday January 12, 2026 through Friday February 6, 2026.

Methodology:

Listeners of **Rock 104.5, ESPN 94.1/1450 AM, 105.7 KOZZ, and Fox Sports Radio 630** will be promoted by on-air personalities and/or station imaging to participate in the **Diamond Peak - Text to Win Giveaway**.

To enter, listeners must text the keyword **“SNOW”** to the **respective station text number** during the Contest Period. All eligible text entries will be entered into the weekly drawings.

1. The **Diamond Peak - Text to Win Giveaway** Contest is open to listeners of KDOT, KOZZ, KPLY & KHIT who are 21+ YEARS and older and are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.
