Winner must be 21 years of age or older

Contest Dates: March 17, 2025 – April 25, 2025

Description of Contest: The 38 radio stations (each, a “**Station**”) in the nine markets identified below (each, a “**Contest Area**”) will conduct the Lotus \$2025 for 2025 Promotion (the “**Contest**”). If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s weekly random selection.

Each of the 38 stations will randomly select a daily winner from its entrants (with respect to each station, that station’s “**Station Entrant**”), and those 38 winners will be entered into a random daily drawing for \$2025. You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win.

Prizes are non-transferable.

Daily winners will be chosen at random approximately 6pm local time and will be entered into the daily Grand Prize drawing that will take place on the following weekday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will have one year from the date on which that prize winner was notified to claim and use the prize. After one-year, the prize will be forfeited.

If we are unable to contact the winner after 5 days from the time their name was drawn that winner is disqualified.

Eligibility:

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Employees of Lotus Communications Corp. or any of its subsidiaries or affiliates (collectively, the "**Company**"), Sponsors, Prize Providers, each of their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. To be eligible to participate in the Contest, entrants must have a valid, working email address.

The Company, Sponsors, and Prize Providers (collectively, "**Supporters**") accept no responsibility or liability in connection with any injuries, losses or damages of any kind, directly or indirectly, caused by or resulting from the acceptance, possession or use of any prize awarded in the Contest. All station decisions relating to the Contest, including the interpretation of the Contest Rules, will be final and binding. The stations reserve the right to make rules and contest changes and change the contest dates, and the right to cancel, terminate, modify or suspend the Contest if in Station's sole determination it believes that the integrity of the Contest has been, or could be, compromised or that the Contest is not capable of running as planned or fairly, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or force majeure or any other causes beyond the stations' control.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

KLPX – PAY YOUR BILLS 2025 CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

HOW TO ENTER/WIN: Listeners of KLPX-FM 96.1 who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KLPX – PAY YOUR BILLS 2025 Contest. There will be two (2) ways to participate in the KLPX – PAY YOUR BILLS 2025 Contest, listeners must do one of/ or all of the following:

1. Weekdays, during the **Contest Period**, during the approximate times of 7:10am, 8:10am, 12:20pm, 2:20pm, and 3:20pm, a KLPX (96.1) DJ will give the KLPX contest texting number (520-600-5579) and a keyword to qualify to win the **\$2025 A Day National Contest Grand Prize**. **One text per phone number, per qualifying hour, per day during the contest period allowed.*
2. The second way to participate will be; during the **Contest Period**, during any KLPX remote, van-stop, or event onsite at any Tucson metro area location, listeners can approach the KLPX promotion staff and ask for a special keyword to text in to the texting number (520-600-5579), and that will count as an entry for that specific date, or if texted after 5pm on a weekday, or on a weekend, it will count towards the following weekday of the contest period. **One text per phone number, per remote, van-stop, event, per day during the contest period allowed.*
3. Each weekday during the **Contest Period**, a daily KLPX- PAY YOUR BILLS 2025 CONTEST QUALIFIER will be chosen at random approximately 6pm local time and will be entered into the daily Grand Prize drawing that will take place on the following weekday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will have one year from the date on which that prize winner was notified to claim and use the prize. LOCAL ELIGIBILITY RESTRICTIONS:

1. The KLPX – PAY YOUR BILLS 2025 Contest is open to listeners of KLPX who are 21 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
2. Employees of KLPX, KFMA, KMXZ, KFFN, KCMT, KTKT, KCMT-HD2, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this **KLPX – PAY YOUR BILLS 2025 Contest**. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
3. Persons who have won a prize in another contest or promotion of any kind from Arizona Lotus within the seven (7) day period immediately preceding the start date of the **KLPX – PAY YOUR BILLS 2025 Contest** are not eligible to participate. Only one person per family or household (whether related or not) may win any promotion from Arizona Lotus during any seven (7) day period.

PRIZES:

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KLPX and Arizona Lotus Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KLPX and Arizona Lotus Corp. are not obligated to make any effort to find an alternative prize under these circumstances.
2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.

5. All KLPX – PAY YOUR BILLS 2025 Contest winners must sign and date official station release and waiver forms as requested. Failure to do so will result in winner forfeiting the prize.

6. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of the KLPX – PAY YOUR BILLS 2025 Contest sponsor and / or the contest administrator if another entrant is to be selected as the winner if time permits.

7. In the event, such an act should occur, KLPX may in its sole discretion, offer the winner comparable prize(s) currently being offered by KLPX in lieu of the Prize originally awarded.

If for any reason, the contest is not capable of running as planned, including without limitation, any suspected evidence of tampering or technological corruption or if any portion of the contest is compromised by virus, bugs, worms or unauthorized human intervention, fraud, an insufficient number of qualified Contest entries, or any other causes beyond the KLPX and Arizona Lotus Corp's control which, in the KLPX and Arizona Lotus Corp. sole opinion, corrupts, threatens or impairs the

administration, security, fairness, integrity, or proper conduct of the Contest, KLPX and Arizona Lotus Corp. reserve the right to cancel, terminate, modify or suspend the contest at their sole discretion.
