#### KCMT - DISNEYLAND TRIP CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

Registration: Friday September 15th, during the times of 5pm through 7pm. (Contest Period)

**Requirements**: Must be 21 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card.

**Grand Prize**: One winner will be awarded a Disneyland grand prize for a family of four (4), which includes, a two (2) night stay at an onsite Disneyland hotel/resort, three-day park tickets for a family of four (4) to be used once per day at either Disneyland or California Adventure, and a one-hundred dollar (\$100) prepaid gift card to use for gas or travel; provided by Disneyland Corporation for promotional purposes. (ARV: \$2,634 per package)

**HOW TO ENTER/WIN:** Listeners of KCMT who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area will be able to take part in the KCMT – Disneyland Trip Contest. To participate in the KCMT – Disneyland Trip Contest, listeners must do the following:

- 1. Visit KCMT tent during a KCMT on-site appearance outside the Linda Ronstadt Music Hall at the Tucson Convention Center, located at 260 S.   - 7:00 pm One (1) raffle ticket will be randomly drawn on-site and the ticket number will be read out loud. The person whose ticket matches the drawing ticket is the Grand Prize winner.
- 3. Entrants must be present to win at the time of the random drawing. Winner will be notified in person onsite and will make an appointment to visit the KCMT offices during business hours to claim prize.

Grand prize winner contact information, phone number and/or email, will be given to the Disneyland Corporation promotions department and will reach out to each individual Grand Prize winner within seven (7) to fourteen (14) calendar days to book the dates and details of the trip. \*Any changes or claims to reservations and use of tickets will be at the discretion of Disneyland Corporation; Disney Corporation rules for this contest at the end of these Arizona Lotus promotion contest rules.

### **ELIGIBILITY RESTRICTIONS:**

- 1. The KCMT Disneyland Trip Contest is open to listeners of KCMT who are 21 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area.
