

\$2024 A Day  
General Contest Rules

No Obligation or Purchase Necessary

The Contest is subject to federal, state and local laws and regulations and is void where prohibited.

Winner must be 18 years of age or older

Contest Dates: Tuesday, February 20, 2024 – March 29, 2024 (Monday – Friday)

Description of Contest: The 38 radio stations (each, a “**Station**”) in the nine markets identified below (each, a “**Contest Area**”) will conduct the Pay Your Bills Promotion (the “**Contest**”) where you can win \$2024 daily Monday - Friday. If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s daily random selection.

Each of the 38 stations will randomly select a daily qualifier from its entrants (with respect to each station, that station’s “**Station Entrant**”).

Each market will then choose one finalist from their combined daily entries to be entered into the daily Grand Prize drawing of \$2024.

Of the remaining 9 Grand Prize finalists one will be selected in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday’s winner will be notified on Monday).

All daily qualifiers will be selected no later than 5pm local time.

You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win.

Prize winners will be notified by telephone, text or email, and will have 3 months from the date on which that prize winner was notified to claim and use the prize. After 3 months, the prize will be forfeited.

If we are unable to contact the winner after 5 days from the time their name was drawn the prize will be forfeited.

**Eligibility:**

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Employees of Lotus Communications Corp. or any of its subsidiaries or affiliates (collectively, the "**Company**"), Sponsors, Prize Providers, each of their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. The Company, Sponsors, and Prize Providers (collectively, "**Supporters**") accept no responsibility or liability in connection with any injuries, losses or damages of any kind, directly or indirectly, caused by or resulting from the acceptance, possession or use of any prize awarded in the Contest. The stations reserve the right to make rules and contest changes and change the contest dates, and the right to cancel, terminate, modify or suspend the Contest if in Station's sole determination it believes that the integrity of the Contest has been, or could be, compromised or that the Contest is not capable of running as planned or fairly, including

infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or force majeure or any other causes beyond the stations' control.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

## KCMT – LA CALIENTE TE ALIVIANA CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

**HOW TO ENTER/WIN:** Listeners of KCMT (La Caliente 92.1/95.7) who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KCMT – La Caliente Te Aliviana Contest. There will be two (2) ways to participate in the KCMT – La Caliente Te Aliviana Contest, listeners must do one of/ or all of the following:

1. Weekdays, during the **Contest Period**, during the approximate times of 7:30am, 8:30am, 1:30pm, and 3:30pm, a KCMT (La Caliente 92.1/95.7) DJ will give the KCMT contest texting number (520-719-0921) and a La Caliente Te Aliviana keyword to qualify to win the **\$2024 A Day National Contest Grand Prize**. *\*One text per phone number, per qualifying hour, per day during the contest period allowed.*
2. The second way to participate will be; during the KCMT (La Caliente 92.1/95.7) remote on Saturday, March 23<sup>rd</sup>, 2024, at O’Rielly Chevrolet of Tucson, located at 6160 E. Broadway Blvd. Tucson, AZ 85711, during the times of 4pm – 6pm, listeners can approach the KCMT promotion staff and ask for a special keyword to text in to the texting number (520-719-0921), and that will count as an entry for the contest date of Monday March 25<sup>th</sup>,2024. *\*One text per phone number, per remote.*
3. Each weekday, during the **Contest Period**, at around 4:30pm, one (1) KCMT listener/participant will be randomly selected from the qualified on-air participants and remote, van-stop, or event participants combined, for the opportunity to be entered to win the **\$2024 A Day National Contest Grand Prize**.
4. Each weekday, during the **Contest Period**, at around 5:00pm, one (1) listener/participant will be randomly selected from all Arizona Lotus Radio stations (KLPX, KFMA, KMXZ, KFFN, KCMT, KTKT, KCMT-HD2) qualifiers, as a finalist for the opportunity to win the **\$2024 A Day National Contest Grand Prize**.
5. One (1) daily Grand Prize winner will be selected from all nine (9) Lotus Corporation radio market finalists in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday’s winner will be notified on Monday).

### LOCAL ELIGIBILITY RESTRICTIONS:

1. The KCMT – La Caliente Te Aliviana Contest is open to listeners of KCMT who are 18 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
2. Employees of KLPX, KCMT, KFMA, KTKT, KCMT, KFFN, KCMT-HD2, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KCMT – La Caliente Te Aliviana Contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
3. Persons who have won a prize in another contest or promotion of any kind from Arizona Lotus within the seven (7) day period immediately preceding the start date of the KCMT – La Caliente Te Aliviana Contest are not eligible to participate. Only one person per family or household (whether related or not) may win in any promotion from Arizona Lotus during any seven (7) day period.

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KCMT and Arizona Lotus Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KCMT and Arizona Lotus Corp. are not obligated to make any effort to find an alternative prize under these circumstances.

2. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.

In the event, such an act should occur, KCMT may in its sole discretion, offer the winner comparable prize(s) currently being offered by KCMT in lieu of the Prize originally awarded.
