Winner and Guest must be 21 years of age or older

Contest Dates: June 17, 2024 – August 9, 2024

Descrip/on of Contest: The 34 radio stations (each, a “**Station**”) in the nine markets iden/fied below (each, a “**Contest Area**”) will conduct the Lotus Summer of Fun Promo/on (the “**Contest**”). If you wish to par/cipate in the Contest, review the local contest rules below for that Sta/on’s Contest Area, which include instruc/ons on how to enter that Sta/on’s weekly random selec/on.

HOW TO ENTER/WIN: Listeners of KCMT (La Caliente 92.1/95.7) who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KCMT – Summer of Fun Contest. There will be multiple ways to participate in the KCMT – Summer of Fun Contest, listeners must do one of/ or all of the following:

3. A second way to participate will be during the **Contest Period**, KCMT (La Caliente 92.1/95.7) DJ's will be instructing listeners to log on to www.KCMT.com and click on the "SUMMER OF FUN CONTEST" tile to complete a contest registration form which includes contact information like telephone/cell phone number and email address. Each contest week's online registration will end on Fridays during the **Contest Period** at 5:59pm and the next contest week's online registration will begin on Fridays during the **Contest Period** at 6:00pm. One registration per week, per computer/IP address, will be allowed.
4. Each Friday, during the contest period, at around 6pm, one (1) listener/participant will be randomly selected from the qualified website registrations and combined with the qualified on-air participants, from there; one (1) listener/participant will be randomly selected to participate in the Lotus Summer of Fun National Contest for the opportunity to win the **Grand Prize**.

6. Qualified registrations from the remotes will be added to the pool of qualified entries as follows:

 - Saturday July 13th, 2024, registrants will be added to the contest week of July 15th, 2024.
 - Monday July 24th, 2024, registrants will be added to the contest week of July 24th, 2024.
 - Saturday August 3rd, 2024, registrants will be added to the contest week of August 5th, 2024.
7. Each Friday at around 6pm, during the contest period, one (1) listener/participant from combined qualified participants, will be randomly selected to participate in the Lotus Summer of Fun National Contest for the opportunity to win the **Grand Prize**.

LOCAL ELIGIBILITY RESTRICTIONS:

1. The KCMT – Summer of Fun Contest is open to listeners of KCMT who are 21 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).

2. Employees of KLPX, KCMT, KCMT, KTKT, KMXZ, KFFN, KCMT-HD2, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KCMT – Summer of Fun Contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.

3. Persons who have won a prize in another contest or promotion of any kind from Arizona Lotus within the seven (7) day period immediately preceding the start date of the KCMT – Summer of Fun Contest are not eligible to participate. Only one person per family or household (whether related or not) may win any promotion from Arizona Lotus during any seven (7) day period.

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KCMT and Arizona Lotus Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KCMT and Arizona Lotus Corp. are not obligated to make any effort to find an alternative prize under these circumstances.

2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.

3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.

6. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of the KCMT – Summer of Fun Contest sponsor and / or the contest administrator if another entrant is to be selected as the winner if time permits.
