

KCMT –PAGA TUS BILES CONTEST 2026 CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

CONTEST PERIOD: Monday, March 16 through Friday, April 24, 2026.

HOW TO ENTER/WIN: Listeners of KCMT-FM 92.1/95.5 who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KCMT –PAGA TUS BILES CONTEST 2026 Contest. There will be two (2) ways to participate in the KCMT –PAGA TUS BILES CONTEST 2026 Contest, listeners must do one of/ or all of the following:

1. Weekdays, during the **Contest Period**, during the approximate times of 7:30am, 8:30am, 1:30pm, and 3:30pm, a KCMT (La Caliente 92.1/95.5) DJ will give the KCMT contest texting number (520-719-0921) and a keyword to qualify to win the **\$2026 A Day** National Contest **Grand Prize**. **One text per phone number, per qualifying hour, per day during the contest period allowed.*
2. The second way to participate will be; during the **Contest Period**, during any KCMT remote, van-stop, or event onsite at any Tucson metro area location, listeners can approach the KCMT promotion staff and ask for a special keyword to text in to the texting number (520-719-0921), and that will count as an entry for that specific date, or if texted after 5pm on a weekday, or on a weekend, it will count towards the following weekday of the contest period. **One text per phone number, per remote, van-stop, event, per day during the contest period allowed.*
3. Each weekday during the **Contest Period**, a daily KCMT- PAGA TUS BILES CONTEST 2026 CONTEST QUALIFIER will be chosen at random approximately 6pm local time and will be entered into the daily Grand Prize drawing that will take place on the following weekday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will have one year from the date on which that prize winner was notified to claim and use the prize. After one-year, the prize will be forfeited. If we are unable to contact the winner after 5 days from the time their name was drawn that winner is disqualified.

LOCAL ELIGIBILITY RESTRICTIONS:

1. The KCMT – PAGA TUS BILES CONTEST 2026 Contest is open to listeners of KCMT who are 21 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
2. Employees of KLPX, KFMA, KMZ, KFFN, KCMT, KTKT, KLPX-HD3, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KCMT – PAGA TUS BILES CONTEST 2026 Contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
3. Persons who have won a prize in another contest or promotion of any kind from Arizona Lotus within the seven (7) day period immediately preceding the start date of the KCMT – PAGA TUS BILES CONTEST 2026 Contest are not eligible to participate. Only one person per family or household (whether related or not) may win any promotion from Arizona Lotus during any seven (7) day period.

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KCMT and Arizona Lotus Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KCMT and Arizona Lotus Corp. are not obligated to make any effort to find an alternative prize under these circumstances.
2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.

If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s weekly random selection.
