Winner and Guest must be 21 years of age or older

Contest Dates: June 22, 2026 – August 14, 2026

Description of Contest: The 37 radio stations (each, a “**Station**”) in the ten markets identified below (each, a “**Contest Area**”) will conduct the Lotus Summer of Fun Promotion (the “**Contest**”). If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s weekly random selection.

Each of the 37 stations will randomly select a weekly winner from its entrants (with respect to each station, that station’s “**Station Entrant**”), and those 37 winners will be entered into a random weekly drawing for one of the following trips for the winner and the winner’s guest (the “**Guest**”). You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win. Once the Grand Prize winner has been selected all entries from that weekly contest will be discarded and registration will begin again for the next Grand Prize.

If prize winner refuses the prize and signs a release provided by its station, the prize winner will be paid \$3,000. Prizes are non-transferable.

Weekly winners will be chosen at random on Fridays at approximately 6pm local time and will be entered into the weekly Grand Prize drawing that will take place on the following Monday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will have one year from the date on which that prize winner was notified to claim and use the prize. After one-year, the prize will be forfeited. Trips may have blackout dates. It is the responsibility of the prize winner to ensure that the prize is used during the one-year period. Winner must have a valid credit for incidentals.

If we are unable to contact the winner after 5 days from the time their name was drawn another winner will be chosen.

Eligibility:

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

HOW TO ENTER/WIN:

Listeners of KCMT (La Caliente 92.1/95.7) who are legal residents of the 48 contiguous United States residing within the Southern Arizona area (from Casa Grande, AZ and below) will be able to take part in the KCMT – LA CALIENTE Verano de Diversión 2026

1. Text to Win:

 - Message & Data Rates May Apply. One text entry per keyword per telephone/cellular number.
2. Online Registration:
 - Listeners can visit www.KCMT.com and click on the “LA CALIENTE Verano de Diversión 2026” tile to complete a contest registration form.
 - Each week’s registration closes on Friday at 5:59 p.m. and reopens at 6:00 p.m.
 - One registration per week, per computer/IP address.
3. Remote Registration:
 - Listeners can fill out a registration form at select KCMT live radio remotes.
 - One registration per person per event day.
 - Dates/Times and Locations TBD
 - Registrations from each remote will be added to the pool for that contest week.

Weekly Drawings:

- Each Friday around 6:00 p.m., one (1) listener/participant from combined qualified participants will be randomly selected to participate in the Lotus Summer of Fun National Contest for the opportunity to win the Grand Prize.

LOCAL ELIGIBILITY RESTRICTIONS:

1. Open to listeners of KCMT who are 21 years of age and older and legal residents within the specified Southern Arizona area.
2. Employees of KLPX, KTKT, KMXZ, KCMT, KFFN, KFMA, KLPX-HD3, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, and other Tucson-area radio stations, and their immediate families or household members are NOT eligible.
