

\$2024 A Day
General Contest Rules

No Obligation or Purchase Necessary

The Contest is subject to federal, state and local laws and regulations and is void where prohibited.

Winner must be 18 years of age or older

Contest Dates: Tuesday, February 20, 2024 – March 29, 2024 (Monday – Friday)

Description of Contest: The 38 radio stations (each, a “**Station**”) in the nine markets identified below (each, a “**Contest Area**”) will conduct the Pay Your Bills Promotion (the “**Contest**”) where you can win \$2024 daily Monday - Friday. If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s daily random selection.

Each of the 38 stations will randomly select a daily qualifier from its entrants (with respect to each station, that station’s “**Station Entrant**”).

Each market will then choose one finalist from their combined daily entries to be entered into the daily Grand Prize drawing of \$2024.

Of the remaining 9 Grand Prize finalists one will be selected in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday’s winner will be notified on Monday).

All daily qualifiers will be selected no later than 5pm local time.

You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win.

Prize winners will be notified by telephone, text or email, and will have 3 months from the date on which that prize winner was notified to claim and use the prize. After 3 months, the prize will be forfeited.

If we are unable to contact the winner after 5 days from the time their name was drawn the prize will be forfeited.

Eligibility:

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Employees of Lotus Communications Corp. or any of its subsidiaries or affiliates (collectively, the "**Company**"), Sponsors, Prize Providers, each of their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. The term "immediate family" includes spouses, domestic partners, grandparents, parents, siblings, children, grandchildren, stepchildren, and any other relatives who reside in the same household with employee.

To be eligible to participate in the Contest, entrants must have a valid, working email address.

Each winner is responsible for paying all local, county, state and federal taxes on prizes based on the estimated retail value of the prizes as set forth in these rules. Each winner must sign a W-9 form.

The Company, Sponsors, and Prize Providers (collectively, "**Supporters**") accept no responsibility or liability in connection with any injuries, losses or damages of any kind, directly or indirectly, caused by or resulting from the acceptance, possession or use of any prize awarded in the Contest. By entering, entrants agree to release each Supporter, and its parent, affiliates, officers, directors, employees and agents, from any and all claims, loss, damage or injury as a result of or incident to such entrant's participation in the Contest or such entrant's use of the prize. Each entrant further acknowledges and agrees that if such entrant wins a prize, the Company has the right to publicize that winning entrant's name, character, likeness, photograph, voice and the fact that entrant is a winner of the Contest for promotional purposes, without financial remuneration.

Each station has the right to disqualify any Station Entrant it determines has not complied with the Contest Rules, including the applicable local station entry rules. All station decisions relating to the Contest, including the interpretation of the Contest Rules, will be final and binding. The stations reserve the right to make rules and contest changes and change the contest dates, and the right to cancel, terminate, modify or suspend the Contest if in Station's sole determination it believes that the integrity of the Contest has been, or could be, compromised or that the Contest is not capable of running as planned or fairly, including

infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or force majeure or any other causes beyond the stations' control.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

KTKT – UNA BUENA LANA CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

HOW TO ENTER/WIN: Listeners of KTKT (La Buena 94.3) who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KTKT – Una Buena Lana Contest. To participate in the KTKT – Una Buena Lana Contest, listeners must do one of/ or all of the following:

1. Weekdays, during the **Contest Period**, during the approximate times of 7:36am, 9:36am, 1:20pm, and 3:30pm, a KTKT (La Buena 94.3) DJ, or a pre-recorded mention, will give the KTKT contest texting number (520-719-0943) and a Una Buena Lana keyword to qualify to win the **\$2024 A Day** National Contest **Grand Prize**. **One text per phone number, per qualifying hour, per day during the contest period allowed.*
2. Each weekday, during the **Contest Period**, at around 4:30pm, one (1) KTKT listener/participant will be randomly selected from the qualified on-air participants for the opportunity to be entered to win the **\$2024 A Day** National Contest **Grand Prize**.
3. Each weekday, during the **Contest Period**, at around 5:00pm, one (1) listener/participant will be randomly selected from all Arizona Lotus Radio stations (KLPX, KFMA, KMXZ, KFFN, KCMT, KTKT, KTKT-HD2) qualifiers, as a finalist for the opportunity to win the **\$2024 A Day** National Contest **Grand Prize**.
4. One (1) daily Grand Prize winner will be selected from all nine (9) Lotus Corporation radio market finalists in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday's winner will be notified on Monday).

LOCAL ELIGIBILITY RESTRICTIONS:

1. The KTKT – Una Buena Lana Contest is open to listeners of KTKT who are 18 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
2. Employees of KLPX, KTKT, KFMA, KCMT, KTKT, KFFN, KTKT-HD2, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KTKT – Una Buena Lana Contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
3. Persons who have won a prize in another contest or promotion of any kind from Arizona Lotus within the seven (7) day period immediately preceding the start date of the KTKT – Una Buena Lana Contest are not eligible to participate. Only one person per family or household (whether related or not) may win in any promotion from Arizona Lotus during any seven (7) day period.

PRIZES:

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KTKT and Arizona Lotus Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KTKT and Arizona Lotus Corp. are not obligated to make any effort to find an alternative prize under these circumstances.
2. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.
4. Prizes will be awarded only upon winner verification and final approval by KTKT.

5. All KTKT – Una Buena Lana Contest winners must sign and date official station release and waiver forms as requested. Failure to do so will result in winner forfeiting the prize.
6. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of the KTKT – Una Buena Lana Contest sponsor and / or the contest administrator if another entrant is to be selected as the winner if time permits.

KTKT and Arizona Lotus Corp. its subsidiaries, its affiliates, participating sponsors and any other promotional parties will not assume any responsibility for any changes in the execution of the contest, including; cancellation of the contest as a result of the occurrence of events not within the control of the KTKT and Arizona Lotus Corp, its subsidiaries, affiliates, participating sponsors, promotional partners and other radio stations, such as acts of nature, strikes, terrorists acts or criminal acts of third parties. In the event, such an act should occur, KTKT may in its sole discretion, offer the winner comparable prize(s) currently being offered by KTKT in lieu of the Prize originally awarded.

If for any reason, the contest is not capable of running as planned, including without limitation, any suspected evidence of tampering or technological corruption or if any portion of the contest is compromised by virus, bugs, worms or unauthorized human intervention, fraud, an insufficient number of qualified Contest entries, or any other causes beyond the KTKT and

Arizona Lotus Corp's control which, in the KTKT and Arizona Lotus Corp. sole opinion, corrupts, threatens or impairs the administration, security, fairness, integrity, or proper conduct of the Contest, KTKT and Arizona Lotus Corp. reserve the right to cancel, terminate, modify or suspend the contest at their sole discretion.

10. Any attempt by an entrant to deliberately undermine the legitimate operation of the contest may be in violation of criminal and civil laws and should such an attempt be made, Arizona Lotus Corp reserves the right to seek remedies and damages (including attorney's fees) from any such entrant to the fullest extent of the law, including criminal prosecution.
