The Contest is subject to federal, state and local laws and regulations and is void where prohibited.

Winner must be 18 years of age or older

Contest Dates: March 16, 2025 – April 24, 2026

Description of Contest: The 37 radio stations (each, a “**Station**”) in the ten markets identified below (each, a “**Contest Area**”) will conduct the Lotus \$2026 for 2026 Promotion (the “**Contest**”). If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s weekly random selection.

Each of the 37 stations will randomly select a daily winner from its entrants (with respect to each station, that station’s “**Station Entrant**”), and those 37 winners will be entered into a random daily drawing for \$2026. You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win.

Prizes are non-transferable.

Daily winners will be chosen at random approximately 6pm local time and will be entered into the daily Grand Prize drawing that will take place on the following weekday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will have one year from the date on which that prize winner was notified to claim and use the prize. After one-year, the prize will be forfeited.

If we are unable to contact the winner after 5 days from the time their name was drawn that winner is disqualified.

Eligibility:

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Employees of Lotus Communications Corp. or any of its subsidiaries or affiliates (collectively, the “**Company**”), Sponsors, Prize Providers, each of their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. The stations reserve the right to make rules and contest changes and change the contest dates, and the right to cancel, terminate, modify or suspend the Contest if in Station’s sole determination it believes that the integrity of the Contest has been, or could be, compromised or that the Contest is not capable of running as planned or fairly, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or force majeure or any other causes beyond the stations’ control.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

KTKT –PAGA TUS BILES CONTEST 2026 CONTEST RULES

No Purchase or Obligation Necessary to enter or win

CONTEST PERIOD: Monday, March 16 through Friday, April 24, 2026.

HOW TO ENTER/WIN: Listeners of KTKT (La Buena 94.3) who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KTKT –PAGA TUS BILES CONTEST 2026 Contest. There will be two (2) ways to participate in the KTKT –PAGA TUS BILES CONTEST 2026 Contest, listeners must do one of/ or all of the following:

1. Weekdays, during the **Contest Period**, during the approximate times of 7:36am, 9:36am, 1:20pm, and 3:30pm, a KTKT (La Buena 94.3) DJ, or a pre-recorded mention, will give the KTKT contest texting number (520-719-0943) and keyword to qualify to win the **\$2026 A Day** National Contest **Grand Prize**. **One text per phone number, per qualifying hour, per day during the contest period allowed.*
2. The second way to participate will be; during the **Contest Period**, during any KTKT remote, van-stop, or event onsite at any Tucson metro area location, listeners can approach the KTKT promotion staff and ask for a special keyword to text in to the texting number (520-719-0943), and that will count as an entry for that specific date, or if texted after 5pm on a weekday, or on a weekend, it will count towards the following weekday of the contest period. **One text per phone number, per remote, van-stop, event, per day during the contest period allowed.*
3. Each weekday during the **Contest Period**, a daily KTKT- PAGA TUS BILES CONTEST 2026 CONTEST QUALIFIER will be chosen at random approximately 6pm local time and will be entered into the daily Grand Prize drawing that will take place on the following weekday no later than 10am PST/11am MST. LOCAL ELIGIBILITY RESTRICTIONS:

1. The KTKT – PAGA TUS BILES CONTEST 2026 Contest is open to listeners of KTKT who are 18 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
2. Employees of KLPX, KFMA, KMXZ, KFFN, KCMT, KTKT, KLPX-HD3, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KTKT – PAGA TUS BILES CONTEST 2026 Contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
3. Persons who have won a prize in another contest or promotion of any kind from Arizona Lotus within the seven (7) day period immediately preceding the start date of the KTKT – PAGA TUS BILES CONTEST 2026 Contest are not eligible to participate. Only one person per family or household (whether related or not) may win any promotion from Arizona Lotus during any seven (7) day period.

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KTKT and Arizona Lotus Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KTKT and Arizona Lotus Corp. are not obligated to make any effort to find an alternative prize under these circumstances.
2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.
