General Contest Rules

No Obligation or Purchase Necessary

The Contest is subject to federal, state and local laws and regulations and is void where prohibited.

Winner must be 18 years of age or older

Contest Dates: Friday, May 1 – Saturday, May 30, 2026

Description of Contest: The 22 radio stations (each, a “**Station**”) in the eight markets identified below (each, a “**Contest Area**”) will conduct the Lotus Soccer giveaway Promotion (the “**Contest**”). If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s Soccer Giveaway random selection.

Bakersfield: KIWI  
Fresno: KHIT-FM, KKBZ, KLBN, KSEQ  
Las Vegas: KWWN, KKGK, KOMP, KXPT, KRLV, KWID, KXPT-HD2

Tucson: KLPX, KFFN, KFMA, KCMT, KTKT

Each of the 22 stations will randomly select one qualifier from all its entrants (with respect to each station, that station’s “**Station Entrant**”), and those 22 winners will be entered into a random Grand Prize drawing for a pair of Soccer tickets. There will only be one Grand Prize.

Grand Prize Package includes:

2 tickets to a great Soccer event Thursday, June 25, 2026. Value \$3,000 (approximate)  
Round Trip Airfare for two (2) approximate value \$900 (unless winner chooses to drive in which case airfare will be deducted from Grand Prize total).  
Hotel for two (2) approximate value \$1000

Total cost (depending on Hotel and Airfare) \$4,900

Prizes are non-transferable. There are no substitutions for prizes and prizes cannot be traded or redeemed for cash.

One winner will be chosen at random on Monday, June 1, 2026. Prize winner will be notified by telephone, text or email. If the Grand Prize winner is unable to attend another winner will be randomly selected.

If we are unable to contact the winner after 5 days from the time their name was drawn that winner is disqualified and another winner will be chosen.

**Eligibility:**

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

**Registration:** Monday, May 4<sup>th</sup>, 2026 at 6:00am through Friday, May 29<sup>th</sup>, 2026 at 5:00pm (Contest Period)

**HOW TO ENTER/WIN:** Listeners of KTKT-FM 94.3 who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KTKT– SOCCER GIVEAWAY 2026 Contest. There will be one (1) way to participate in the KTKT – SOCCER GIVEAWAY 2026 Contest, listeners must do the following:

### TEXT TO WIN

1. Beginning Monday, May 4<sup>th</sup>, through Friday, May 29<sup>th</sup>, 2026, a KTKT DJ will be giving out the KTKT contest texting number (520-719-0943) and a keyword. These keywords will be provided randomly and at least 4 times per day on weekdays.
2. Each listener who texts during these cues will be automatically registered for the opportunity to win the **GRAND Prize**. Message & Data Rates May Apply.

On Friday, May 29<sup>th</sup> at 5pm local time, one KTKT – SOCCER GIVEAWAY 2026 Contest QUALIFIER will be chosen at random from all text entries collected during the Contest Period and that station entrant will be entered into the Grand Prize drawing that will take place on Monday, June 1<sup>st</sup>, 2026. Prize winners will be notified by telephone, text or email. If we are unable to contact the winner after 5 days from the time their name was drawn that winner is disqualified and another winner will be chosen.

### LOCAL ELIGIBILITY RESTRICTIONS:

1. The KTKT – SOCCER GIVEAWAY 2026 Contest is open to listeners of KTKT who are 18 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
2. Employees of KLPX, KTKT, KMXZ, KFFN, KCMT, KTKT, KLPX-HD3, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KTKT – SOCCER GIVEAWAY 2026 Contest. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
