(ARV: \$700)

# HOW TO ENTER/WIN:

Listeners of KCMT-HD2 (EXITO 93.3) La Caliente who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area and are 21 years of age and older will be able to take part in KCMT-HD2 (EXITO 93.3) - Disneyland Contest.
