

# The Ultimate Big Game Package Contest

## Official Rules KDOT, KOZZ, KTHX & KXZZ

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

### **1. Sponsor**

The Ultimate Big Game Package Contest (“Contest”) is sponsored by **Reno Lotus Radio Corp.** (“Sponsor”), owner and operator of radio stations **KDOT, KOZZ, KTHX, and KXZZ** (collectively, the “Stations”).

### **2. Eligibility**

The Contest is open to **legal residents of the State of Nevada**, residing within the **Reno–Carson City–Lake Tahoe–Sparks radio market**, who are **twenty-one (21) years of age or older** at the time of entry.

Employees of Sponsor, its parent companies, subsidiaries, affiliates, advertising or promotional agencies, participating sponsors, and their immediate family members (spouse, parent, child, sibling, or grandparent) and household members (whether related or not) are not eligible to participate or win.

Individuals who have won a prize in any promotion conducted by Reno Lotus Radio Corp. within the **fourteen (14) days immediately preceding** the start of this Contest are not eligible. Only **one (1) prize winner per household** may win any promotion from Reno Lotus Radio Corp. during any fourteen (14)-day period.

### **3. Contest Period**

The Contest begins **Monday, January 19, 2026** and ends **Wednesday, February 4, 2026** (“Contest Period”).

Sponsor’s studio clocks are the official time-keeping devices for the Contest.

### **4. How to Enter / Qualify**

Listeners may qualify by listening to KDOT, KOZZ, KTHX, or KXZZ during the Contest Period.

During the Contest Period, a Station DJ will play **The Ultimate Big Game Package** sounder **two (2) times per weekday** between **8:00 a.m. and 5:00 p.m.**, Monday through Friday, excluding holidays.

After the sounder airs, the following callers will qualify:

- **KDOT:** 12th caller at 775-737-5368
- **KOZZ:** 11th caller at 775-737-5699
- **KTHX:** 9th caller at 775-333-0945
- **KXZZ:** 10th caller at 775-280-9336

Each eligible listener may qualify **one (1) time only** during the Contest Period, regardless of station.

A total of **ninety-six (96) qualifiers** will be selected.

Sponsor is not responsible for busy signals, disconnected calls, technical malfunctions, human error, or calls not completed.

## **5. Winner Selection**

One (1) **Grand Prize Winner** will be selected in a **random drawing** from all eligible qualifiers on **Thursday, February 5, 2026**, at approximately **10:00 a.m.**

Odds of winning depend upon the number of eligible qualifiers received.

## **6. Grand Prize**

One (1) Grand Prize Winner will receive:

- One (1) 75" 4K LED Television (Approximate Retail Value: \$450)
- One (1) La-Z-Boy Rocking Recliner (Approximate Retail Value: \$699)

Total Approximate Retail Value ("ARV"): **\$1,149**

Prizes are provided by Sponsor for promotional purposes.

No cash substitution, transfer, or assignment of prize is permitted, except at Sponsor's sole discretion in the event of prize unavailability, in which case a prize of equal or greater value may be substituted.

## **7. Winner Notification & Prize Claim**

The potential winner will be notified by telephone and/or email using the contact information provided at the time of qualification.

The potential winner must respond within **forty-eight (48) hours** of notification and must present valid government-issued photo identification. Failure to respond or complete required documentation may result in forfeiture of the prize and selection of an alternate winner, time permitting.

Winner must execute all required affidavits of eligibility, liability releases, and publicity releases prior to receipt of the prize.

Prizes must be picked up at a location designated by Sponsor. Delivery, installation, and setup are not included.

## **8. Taxes**

Winner is solely responsible for all federal, state, and local taxes associated with the receipt or use of the prize. Sponsor may issue an IRS Form 1099 if required by law.
