To participate in the SAID CONTEST listeners must do the following:

- 1) Starting Monday June 17th through Friday August 9th, Listeners of KDOT, KOZZ, KTHX AND KXZZ who meet the requirements listed and are legal residents, currently residing in Nevada or California will be able to enter to win one of the prize trips provided. One winning qualifier from each station: KDOT, KOZZ, KTHX, KXZZ will be drawn and entered into the Lotus Grand Prize drawing. Participants may qualify once per week through on-air qualifier contesting and QR code scanning. On-air contesting per KDOT, KOZZ, KTHX AND KXZZ will consist of being the specified number caller per station when the 'Summer of Fun" sounder is played. The same sounder will be played on all participating stations. Sounder will be played two times per day, Monday through Friday, between 6a 5p, at varied times per station; with the exception of Holidays. Participants may qualify only once per week, per station. There will be a total of 10 on-air qualifiers per station per week.
- 2) In addition, participants may also become a weekly qualifier via QR code scanning drawing. Participants for QR code drawing will be prompted to visit

all of the participating local businesses to scan the QR code for that location and specified per station, and enter their information to be registered. Participants may register once per participating location, per station each week. QR code scanning participants have till Friday at 11am to register each week. There will be one weekly QR code qualifier drawn per station, at approx. 1:00 pm each week. These QR code qualifiers will then be put into the pool with the corresponding station's 10 on-air qualifiers for the weekly final qualifier drawing per station to happen each Friday at approx. 3:00pm.
