

# KTHX - "Abre y Gana" (Open & Win) Contest Rules

No Purchase or Obligation Necessary to enter or win.

#### CONTEST DESCRIPTION

**Registration**: Beginning Monday October 13th 12:00 AM through Friday November 21st, 2025 5:00 PM (6 weeks)

**Requirements**: Winner must be 21+ years of age or older and have a valid Nevada Driver's License or Government Issued Identification Card.

**Prizes**: Category A (Grand Level Prize), Category B (Mid-Level Prize) or Category C (Entry-Level Prize)

**Registration**: Beginning Monday October 13th 12:00 AM through Friday November 21st, 2025 5:00 PM. (60 prizes total).

Category A (Grand Level Prize)

- (3) 4-pack of tickets to Disney for selected day (4) 1 day, 1 park passes \$700/pack prizes are provided by KTHX for promotional purposes
- (2) Pair of tickets to Perfume de Gardenia Show at Grand Sierra Resort 11/15 \$300/pair prizes are provided by Grand Sierra Resort for promotional purposes.
- (2) Pair of tickets to YURI at Grand Sierra Resort 12/5 \$200/pair prizes are provided by Grand Sierra Resort for promotional purposes.

Category B (Mid-Level Prize)

(5) Pair of tickets to the Jaripeo/Banda Recodo 10/11 - \$100/pair - prizes are provided by MB Entertainment for promotional purposes

Category C (Entry-Level Prize)

**Methodology:** Listeners of KTHX who are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas will be able to take part in the **KTHX – "Abre y Gana" Contest.** To participate in the said contest, listeners must do the following:

- 1. Beginning Monday October 13th 12:00 AM through Friday November 21st, 2025 5:00 PM KTHX DJ will prompt listeners to be the 9<sup>th</sup> caller.
- 2. The correct caller is given the chance to play "Abre y Gana."
- 3. The caller chooses **one of three doors.** Each door contains a prize from one of the categories:

Prize distribution is randomized to keep each play unpredictable.

A Prize (Big prize)

B Prize (Mid-level prize)

C Prize (Entry-level prize)

- 4. Slogan Challenge:
- Before picking, the jock asks the caller to recite the station slogan.
  The Slogan is "Aqui Suena, La Que Buena"

- If the caller answers **correctly**, they earn the option to **trade** their prize after their first door reveal.
- If the caller answers the slogan incorrectly, they only get one pick and must keep whatever is behind their first door.

## 5. Outcome:

- The caller wins the prize behind the door(s) they final select.
- · Every play results in a prize win
  - 6. **Frequency**: Two (2) giveaways per weekday in the 12p & 5p hours between Monday October 13th 12:00 AM through Friday November 21st, 2025 5:00 PM, excluding holidays (60 total instances).

## **ELIGIBILITY RESTRICTIONS:**

- 1. The KTHX "Abre y Gana" Contest. is open to listeners of KDOT who are 21+ YEARS and older and are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.
- 2. Employees of KOZZ, KDOT, KXZZ, KTHX, KHIT, KFOY, KPLY, Reno Lotus Radio Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Reno/Tahoe metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this **KTHX "Abre y Gana" Contest.** For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.
- 3. Persons who have won a prize in another contest or promotion of any kind from Reno Lotus Radio Corp. Across all stations within the fourteen (14) day period immediately preceding the start date of **KTHX** "**Abre y Gana**" **Contest** are not eligible to participate. Only one person per family or household (whether related or not) may win any promotion from Reno Lotus Radio Corp during any fourteen (14) day period.
