General Contest Rules

No Obligation or Purchase Necessary

The Contest is subject to federal, state and local laws and regulations and is void where prohibited.

Winner and Guest must be 21 years of age or older

Contest Dates: June 22, 2026 – August 14, 2026

Description of Contest: The 37 radio stations (each, a “**Station**”) in the ten markets identified below (each, a “**Contest Area**”) will conduct the Lotus Summer of Fun Promotion (the “**Contest**”). If you wish to participate in the Contest, review the local contest rules below for that Station’s Contest Area, which include instructions on how to enter that Station’s weekly random selection.

Each of the 37 stations will randomly select a weekly winner from its entrants (with respect to each station, that station’s “**Station Entrant**”), and those 37 winners will be entered into a random weekly drawing for one of the following trips for the winner and the winner’s guest (the “**Guest**”). You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win. Once the Grand Prize winner has been selected all entries from that weekly contest will be discarded and registration will begin again for the next Grand Prize.

If prize winner refuses the prize and signs a release provided by its station, the prize winner will be paid \$3,000. Prizes are non-transferable.

Weekly winners will be chosen at random on Fridays at approximately 6pm local time and will be entered into the weekly Grand Prize drawing that will take place on the following Monday no later than 10am PST/11am MST. Prize winners will be notified by telephone, text or email, and will have one year from the date on which that prize winner was notified to claim and use the prize. After one-year, the prize will be forfeited. Trips may have blackout dates. It is the responsibility of the prize winner to ensure that the prize is used during the one-year period. Winner must have a valid credit for incidentals.

If we are unable to contact the winner after 5 days from the time their name was drawn another winner will be chosen.

Eligibility:

To be eligible to participate in the Contest, entrants must be U.S. residents who are at least the Age of Eligibility and reside in the Contest Area.

Employees of Lotus Communications Corp. or any of its subsidiaries or affiliates (collectively, the “**Company**”), Sponsors, Prize Providers, each of their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. The term “immediate family” includes spouses, domestic partners, grandparents, parents, siblings, children, grandchildren, stepchildren, and any other relatives who reside in the same household with employee.

To be eligible to participate in the Contest, entrants must have a valid, working email address.

Each winner is responsible for paying all local, county, state and federal taxes on prizes based on the estimated retail value of the prizes as set forth in these rules. Each winner must sign a W-9 form.

The Company, Sponsors, and Prize Providers (collectively, “**Supporters**”) accept no responsibility or liability in connection with any injuries, losses or damages of any kind, directly or indirectly, caused by or resulting from the acceptance, possession or use of any prize awarded in the Contest. By entering, entrants agree to release each Supporter, and its parent, affiliates, officers, directors, employees and agents, from any and all claims, loss, damage or injury as a result of or incident to such entrant’s participation in the Contest or such entrant’s

use of the prize. Each entrant further acknowledges and agrees that if such entrant wins a prize, the Company has the right to publicize that winning entrant's name, character, likeness, photograph, voice and the fact that entrant is a winner of the Contest for promotional purposes, without financial remuneration.

Each station has the right to disqualify any Station Entrant it determines has not complied with the Contest Rules, including the applicable local station entry rules. All station decisions relating to the Contest, including the interpretation of the Contest Rules, will be final and binding. The stations reserve the right to make rules and contest changes and change the contest dates, and the right to cancel, terminate, modify or suspend the Contest if in Station's sole determination it believes that the integrity of the Contest has been, or could be, compromised or that the Contest is not capable of running as planned or fairly, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or force majeure or any other causes beyond the stations' control.

Each station, in its sole discretion, reserves the right to disqualify from the Contest any person (and all that person's entries) who tampers with the entry process or the operation of the Contest, provides untruthful information or is otherwise in violation of the Contest Rules.

Summer of Fun 2026 Contest Rules

KDOT, KOZZ, KXZZ & KTHX

No purchase necessary. Void where prohibited. Subject to all federal, state, and local laws and regulations.

Contest Description:

The “Summer of Fun 2026” promotion runs from June 22, 2026 through August 8, 2026 (the “Promotion Period”). The promotion is conducted by KDOT, KOZZ, KXZZ, and KTHX (the “Stations”), and is part of a larger multi-market promotion conducted by Lotus Broadcasting.

Eligibility:

Open to legal residents of the 48 contiguous United States who are 21 years of age or older and reside within Reno, Carson City, Lake Tahoe, Sparks, and surrounding areas. Winners and their guests must be 21 years of age or older and possess a valid Nevada driver’s license or government-issued identification.

How to Enter and Qualify:

Listeners may attempt to qualify for weekly drawings via on-air contests and live remote broadcasts. No purchase is necessary to participate, and participation in remote broadcasts is not required to enter or win.

On-Air Qualification:

- During the Promotion Period, each station (KDOT, KOZZ, KTHX, KXZZ) will conduct on-air contests Monday through Friday.
- Listeners must call in when the “Summer of Fun” sounder is played and be the designated caller number announced.
- Each station will air the sounder three (3) times per weekday between 6:00 AM and 7:00 PM at varied times.
- Each station will select fifteen (15) on-air qualifiers per week.
- Participants may qualify once per week, per station, via on-air contesting.

Live Remote Broadcast Qualification:

- Live remote broadcasts may be conducted during the Promotion Period; however, such broadcasts are not guaranteed to occur every week.
- Remote broadcasts are not required for entry, and listeners may fully participate via on-air contesting regardless of whether a remote broadcast occurs.
- When conducted, remote broadcast dates, times, and locations will be posted on station websites at least seven (7) days in advance.

- Participants may register once per station at each remote broadcast.
- One (1) qualifier per station will be randomly selected from eligible entries received at each broadcast.

Weekly Station Finalists:

- Each week, all qualifiers for each station (fifteen (15) on-air qualifiers plus one (1) remote qualifier, if applicable) will be entered into a weekly station drawing.
- One (1) weekly finalist per station will be selected each Friday at approximately 3:00 PM.
- Participants may qualify multiple times within the same week through different entry methods; however, a participant may only be selected as a weekly finalist once per station per week.

Multi-Market Grand Prize Drawings:

- Each weekly station finalist will advance to a corporate-level drawing that includes qualifying participants from all participating Lotus Broadcasting stations (approximately 37 stations across 10 markets).
- One (1) grand prize winner will be selected from this combined pool each week.
- A new contest cycle begins each week during the Promotion Period.

Prizes:

Weekly grand prizes consist of trip packages, as detailed in official prize descriptions provided separately by Lotus Broadcasting.

ELIGIBILITY RESTRICTIONS:

1. The KDOT, KOZZ, KXZZ & KTHX – Summer of Fun 2026 Promotion is open to listeners of KDOT, KOZZ, KXZZ & KTHX who are 21+ YEARS and older and are legal residents of the 48 contiguous United States residing within the RENO/CARSON CITY/LAKE TAHOE/SPARKS and surrounding areas.

2. Employees of KOZZ, KDOT, KXZZ, KTHX, KHIT, KFOY, KPLY, Reno Lotus Radio Corp, and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Reno/Tahoe metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this The KDOT, KOZZ, KXZZ & KTHX – Summer of Fun 2026 Promotion. For purposes of this contest, immediate family members mean spouses, parents, grandparents, children, and siblings and their respective spouses are not eligible.

3. Persons who have won a prize in another contest or promotion of any kind from Reno Lotus Radio Corp. Across all stations within the fourteen (14) day period immediately preceding the start date of the KDOT, KOZZ, KXZZ & KTHX – Summer of Fun 2026 promotion are not eligible to participate. You may only win a Grand Prize one time. Only one person per family or household (whether related or not) may win any promotion from Reno Lotus Radio Corp during any fourteen (14) day period.

PRIZES:

1. Dates and times of concerts, trips, events, and activities promoted by event sponsors are subject to change and those changes are deemed to be beyond the control of KDOT, KOZZ, KXZZ, KTHX and Reno Lotus Radio Corp. Changes of venue, cancellation of engagements by performing artists, and/or their management may be permanent in nature. KDOT, KOZZ, KXZZ, KTHX and Reno Lotus Radio Corp. are not obligated to make any effort to find an alternative prize under these circumstances. In the event of cancellation or reschedule, for whatever reason, the contest becomes null and void and no future/further prize(s) will be awarded.

2. To the extent that prize elements are provided by third-party providers, the winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith.

3. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by station management and/or the sponsor in its sole discretion.

4. Prizes will be awarded only upon winner verification and final approval by Reno Lotus Radio Corp.

5. The KDOT, KOZZ, KXZZ & KTHX – Summer of Fun 2026 Promotion winners must sign and date official station release and waiver forms as requested. Failure to do so will result in the winner forfeiting the prize.

6. If for any reason a contest winner provides notice that they have decided not to accept an awarded prize, the winner may be required to sign a release form acknowledging forfeiture of the prize. It will be at the discretion of The KDOT ,KOZZ, KXZZ & KTHX – Summer of Fun 2026 Promotion sponsor and / or the contest administrator if another entrant is to be selected as the winner if time permits.

7. In the event any winner is found to be in violation of these Official Rules or is otherwise determined by KDOT, KOZZ, KXZZ & KTHX, in its sole discretion to be ineligible, he/she may be required to forfeit the prize or to reimburse KDOT ,KOZZ, KXZZ, KTHX and /or any sponsor for the stated value of the prize if such a violation is found after the prize has been used by winner.

8. If the winner is unable to pick-up or redeem their prize, there will be no transfer of said prize to another party for pickup or redemption.

9. Contests, unless otherwise specified, may only be won once every 14 days.

GENERAL CONDITIONS:

9. So long as no participant is materially adversely affected, KDOT, KOZZ, KXZZ & KTHX reserves the right to make changes in the contest rules, which will become effective upon being announced on the air and / or posted online.

KDOT, KOZZ, KXZZ, KTHX and Reno Lotus Radio Corp., participating sponsors and their respective parent companies, subsidiaries, affiliates or their representatives, agents and employees are not responsible for the inability of any contestant to complete or continue a telephone call, facsimile transmission or internet registration due to equipment malfunction, busy lines, inadvertent disconnections, unavailable network, server, Internet Service Provider (ISP) or other connections, communication failures or human error that may occur in the transmission, receipt or processing of entries. In addition, KDOT, KOZZ, KXZZ, KTHX and Reno Lotus Radio Corp, participating sponsors and their respective parent companies, subsidiaries, affiliates or their representatives, agents and employees are not responsible for lost, misdirected, mutilated, illegible or incomplete contest entries. Once submitted, entries become the property of KDOT, KOZZ, KXZZ, KTHX and Reno Lotus Radio Corp and will not be returned.

By accepting the prize, the winner acknowledges that KDOT, KOZZ, KXZZ, KTHX and Reno Lotus Radio Corp. have neither made, nor are in any manner responsible or liable for, any warranty, representation or guarantee, express or implied, in fact or in law, relative to the prize or to any portion thereof, including but not limited to its quality, mechanical condition or fitness for a particular purpose.

KDOT, KOZZ, KXZZ & KTHX and Reno Lotus Radio Corp. its subsidiaries, its affiliates, participating sponsors and any other promotional parties will not assume any responsibility for any changes in the execution of the contest, including; cancellation of the contest as a result of the occurrence of events not within the control of the KDOT, KOZZ, KXZZ & KTHX and Reno Lotus Radio Corp, its subsidiaries, affiliates,

participating sponsors, promotional partners and other radio stations, such as acts of nature, strikes, terrorists acts or criminal acts of third parties. In the event such an act should occur, KDOT, KOZZ, KXZZ & KTHX may, in its sole discretion, offer the winner comparable prize(s) currently being offered by KDOT, KOZZ, KXZZ & KTHX in lieu of the Prize originally awarded.
