Listeners can also register to be qualified at weekly remotes and van hits in Kern County.

Each week one qualifier from each station will be sent to corporate to be entered into the weekly drawing to win the Summer of Fun Trip prize. Remotes and Van hit locations and times will be announced on the air.

Grand Prize winner will be notified by telephone, text or email.

Listeners can enter to qualify one time per week. Qualifiers do not roll over week to week.
