#### KMXZ - DISNEYLAND RESORT CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

## **CONTEST DESCRIPTION:**

Registration: Beginning Monday February 19th through Friday March 1st, 2024. (Contest Period)

**Requirements**: Must be 21 years of age or older and have a valid Arizona Driver's License or Government Issued Identification Card.

**Prize**: Six (6) separate individual winners will be awarded four (4) Disneyland Resort 2-Day, 1-Park per day tickets, and a three-hundred dollar (\$300) prepaid gift card to use for gas or travel; tickets provided by Disneyland Corporation and the travel gift card provided by Grand Promo for promotional purposes. (ARV: \$610)

**Grand Prize**: One winner will be awarded a Disneyland grand prize for a family of four (4), which includes, a two (2) night stay at an onsite Disneyland hotel/resort, three-day park tickets for a family of four (4) to be used once per day at either Disneyland or California Adventure, and a one-hundred dollar (\$100) prepaid gift card to use for gas or travel; Disneyland Resort hotel and ticket package provided by Disneyland Corporation and the travel gift card provided by Grand Promo for promotional purposes (ARV: \$2,634 per package)

**HOW TO ENTER/WIN:** Listeners of KMXZ who are legal residents of the 48 contiguous United States residing within the Tucson, Arizona metropolitan area will be able to take part in the KMXZ – Disneyland Resort Contest. To participate in the KMXZ – Disneyland Resort Contest, listeners must do the following:

## **ELIGIBILITY RESTRICTIONS:**

- 1. The KMXZ Disneyland Resort Contest is open to listeners of KMXZ who are 21 years of age and older and are legal residents of the 48 contiguous United States residing with the Tucson, Arizona metropolitan area.
- 2.
