\$2024 A Day General Contest Rules

No Obligation or Purchase Necessary

The Contest is subject to federal, state and local laws and regulations and is void where prohibited.

Winner must be 18 years of age or older

Contest Dates: Tuesday, February 20, 2024 – March 29, 2024 (Monday – Friday)

<u>Description of Contest</u>: The 38 radio stations (each, a "**Station**") in the nine markets identified below (each, a "**Contest Area**") will conduct the Pay Your Bills Promotion (the "**Contest**") where you can win \$2024 daily Monday - Friday. If you wish to participate in the Contest, review the local contest rules below for that Station's Contest Area, which include instructions on how to enter that Station's daily random selection.

Bakersfield: KQKZ, KIWI, KPSL, KCHJ AM/FM

Each of the 38 stations will randomly select a daily qualifier from its entrants (with respect to each station, that station's "Station Entrant").

Each market will then choose one finalist from their combined daily entries to be a entered into the daily Grand Prize drawing of \$2024.

Of the remaining 9 Grand Prize finalists one will be selected in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday's winner will be notified on Monday).

All daily qualifiers will be selected no later than 5pm local time.

You may only win a Grand Prize one time. Only one person per family per household (whether related or not) may win.

KMXZ - CASH PAL CONTEST RULES

No Purchase or Obligation Necessary to enter or win.

HOW TO ENTER/WIN: Listeners of KMXZ (94.9 MIXfm) who are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below) will be able to take part in the KMXZ – Cash Pal Contest. There will be two (2) ways to participate in the KMXZ – Cash Pal Contest, listeners must do one of/ or all of the following:

- Weekdays, during the *Contest Period*, during the approximate times of 6:30am, 7:30am, 10:20am, 2:20pm, 3:20pm, and 4:40pm, a KMXZ (94.9 MIXfm) DJ will give the KMXZ contest texting number (520-775-0949) and a Cash Pal keyword to qualify to win the \$2024 A Day National Contest Grand Prize. *One text per phone number, per qualifying hour, per day during the contest period allowed.
- 2. The second way to participate will be; during the *Contest Period*, during any KMXZ (94.9 MIXfm) remote, van-stop, or event onsite at any Tucson metro area location, listeners can approach the KMXZ promotion staff and ask for a special keyword to text in to the texting number (520-775-0949), and that will count as an entry for that specific date, or if texted after 5pm on a weekday, or on a weekend, it will count towards the following weekday of the contest period. *One text per phone number, per remote, van-stop, event, per day during the contest period allowed.
- 3. Each weekday, during the *Contest Period*, at around 4:55pm, one (1) KMXZ listener/participant will be randomly selected from the qualified on-air participants and remote, van-stop, or event participants combined, for the opportunity to be entered to win the \$2024 A Day National Contest *Grand Prize*.

Each weekday, during the *Contest Period*, at around 5:00pm, one (1) listener/participant will be randomly selected from all Arizona Lotus Radio stations (KLPX, KFMA, KMXZ, KFFN, KCMT, KTKT, KCMT-HD2) qualifiers, as a finalist for the opportunity to win the \$2024 A Day National Contest *Grand Prize*.
- 5. One (1) daily Grand Prize winner will be selected from all nine (9) Lotus Corporation radio market finalists in a random drawing and be notified of their Grand Prize of \$2024 the following day (Friday's winner will be notified on Monday).

LOCAL ELIGIBILITY RESTRICTIONS:

- 1. The KMXZ Cash Pal Contest is open to listeners of KMXZ who are 18 years of age and older and are legal residents of the 48 contiguous United States residing within the Southern, Arizona area (from Casa Grande, AZ and below).
- 2. Employees of KLPX, KCMT, KFMA, KTKT, KMXZ, KFFN, KCMT-HD2, Arizona Lotus Corp and its subsidiaries, affiliates, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Tucson, Arizona metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this KMXZ Cash Pal Contest.
